On 9/7/19 I received a phone call from Lt. Stanger asking if I was able to respond to assist with coverage for a critical incident. I arrived at the PD and began taking calls for service.

At approximately 0101hrs while at 77th and 12th I came in contact with two parties who one of the parties ID'd herself as the sister to the male involved in the incident. I escorted the female and the male to the command post area where they were contacted by Detective Nybeck of the Hennepin County Sheriff's Office.

At approximately 0233hrs while at 77th and Portland I came in contact with a female who Id'd herself as an aunt to the male involved in the incident. I transported her to the area of 77th and Chicago where she was contacted by other family members.

I then was tasked with removing the Richfield squads from the incident scene. At 0430hrs I removed squad 1717 from the scene with a beginning mileage as 54100.5. I arrived at the Richfield PD with an ending mileage of 54102.3. Before removing the squad from the scene I entered a disposition into the camera system.

I then removed squad 1599 at 0443hrs with a beginning mileage of 23736.4. I arrived at the Richfield PD with an ending mileage of 23738.1. The squad camera was already off prior to my entering the squad.

I then removed squad 1505 at 0455hrs with a beginning mileage of 83783.6. I arrived at the Richfield PD with an ending mileage of 83785.3. Before removing the squad from the scene I entered a disposition into the camera system.

I then removed the final squad 1927 at 0505hrs with a beginning mileage of 20276.4. I arrived a the Richfield PD with an ending mileage of 20278.4. Before removing the squad from the scene I entered a disposition into the camera system.

It should be noted that for each squad I shut down the computer system while enroute back to the Richfield PD.

This ended my involvement in the incident.
