Narrative Title: Request to assist PD Narrative Author: Wood, Jenell Narrative Date: 09/10/2019 14:12:48

Narrative:

Dispatched for a "fire other related call" to 77th and Chicago. Dispatch advised E1 that officers were involved in a shooting and were requesting a privacy barrier such as a large blanket or tarp to the scene. E1 responded to the area of 77th and Chicago. R1 also responded and staged nearby away from the scene.

E1 arrived in the area of 77th and Chicago driving east bound from Portland Ave. There was a vast amount of squads and emergency lights. Upon arrival, I confirmed the location PD wanted E1 to respond to. When we arrived from the west at 77th and Chicago we were redirected to enter from the east on 77th Street. E1 responded to 77th Street from 12th Avenue. We staged facing west bound in the east bound lanes on 77th adjacent to a parking lot entrance for the apartment complex.

We brought multiple tarps and tape to the scene. We were requested to create a privacy barrier between the area on the median where the patient's body was lying and the crowd that was gathered near the apartment buildings and the apartment parking lot areas. There were multiple squad cars in the east bound lanes between the crowd and the median as well as multiple areas marked off with yellow tape. The crowd was yelling and there was a line of officers on the curbline and sidewalk area. We began to construct a privacy barrier with tarps and tape. There was a large span of open space with few trees or streetlights.

I requested a select callback and requested R1 (FF Keis and FF Chapeau) to the scene for assistance. They were directed to come in from the east and stage near E1. They provided additional equipment and assistance in constructing, lifting and securing the privacy screen/barrier. We were able to attach the tarps with fire scene tape to the squad cars in the area that were not involved in the incident. Pike poles and a ladder were used to stabilize the top of of the barrier.

Two personnel arrived on the callback at Station #1. Personnel at Station #1 gathered additional items from the station including utility rope/cord and zip ties. RFD was dispatched on a medical and Q1 responded (FF Crofford and FF Chwialkowski) from Station #1. When Q1 was clear of the medical call, they responded near 77th Street and brought the requested items including additional pike poles, zip ties and utility rope to the scene. Q1 personnel was cleared and returned to Station #1. R1 remained on scene to help stabilize the barrier with the additional equipment and was cleared.

E1 (Capt. Wood and FF Wienholz) remained on scene and were requested by PD and Hennepin Sheriff officers to maintain the privacy barrier until the medical examiner arrived and removed the body from the scene. A full callback was requested by Lt. Nelson who was running city operations. Richfield C2 responded to the Station #1 and was advised of the events on scene. Throughout the incident, I maintained contact with C2 regarding the situation on scene and staffing needs.

E1 remained on scene to maintain the privacy barrier. The conditions were windy and rainy. After the crowd dissipated and officers were being released, we were requested to block westbound traffic at 12th Avenue. Once the medical examiner removed the body, the privacy barrier was deconstructed and equipment was returned to E1. I requested replacement vehicle for E1 blocking west bound traffic. When a replacement vehicle was in place, E1 cleared.
