On 09/07/2019, I, Officer Santos #75, responded to the area of 77 th Street and Chicago Avenue in Richfield to assist Richfield and Edina Officers. Prior to my arrival, Dispatch advised there had been an officer-involved shooting in the area and the residents of a nearby apartment complex were acting out of control and coming after officers.							
At 2341 hours, I arrived on scene and reported to Incident Command. I was ordered to assist in maintaining the perimeter on 77 th Street on the north side of the Seasons Park Apartments located at 951 E 77 th St. When I arrived at my position, I activated my body worn camera and observed a loud and seemingly agitated crowd. While maintaining this perimeter, I assisted Richfield Fire in erecting a privacy tarp so that the crime scene technicians could perform their duties.							
On 09/08/2019 at approximately 0100 hours, Bloomington Sergeant Giles relieved me of my position. I cleared the scene at approximately 0110 hours.
