The Challenge: Auto Theft is Prevalent and Hard to Solve

- In 2023, there were 9,784 motor vehicle theft incidents reported to the BCA by law enforcement agencies in Hennepin County.
- The percentage of those cases with a clearance reported to the BCA by law enforcement was about 4%.
- Law enforcement was often indicating that they knew which young people were involved but did not have sufficient evidence to submit a case for prosecution.
- Youth auto theft can be associated with repeat system contact. HCAO data for 2019 youth motor vehicle theft cases charged and not diverted suggests a 1-year recidivism rate of 58%, a 2-year recidivism rate of 63%, and an overall recidivism rate of 68%.

The Solution – HCAO Youth Auto Theft Early Intervention Pilot

In June 2023, HCAO initiated a pilot to address these challenges. We focused on two approaches:

Creation of an early intervention services pathway to offer voluntary services and resources outside of the traditional legal system

Expedited legal system intervention for youth who have auto theft-related cases submitted to HCAO



Early Intervention Services Pathway

Law enforcement submits referrals

HCAO reviews for eligibility

For eligibility

Youth screened as eligible are referred to social workers for outreach and services



Eligibility and Referral for Services June 2023 – May 2024

- Among the 205 young people referred from June 2023 – May 2024, 107 (52%) were screened in as eligible for services.
- Among the 107 eligible for services, 105 (98%) have been referred to a service provider for outreach and services.
- Among those screened out, the majority were because of active court cases, active probation, or non-Hennepin residency.





Early Intervention Referring Agency June 2023 – May 2024

- Each referral is attributed to one agency. Multiple agencies can refer the same young person; in those cases, each submission will be recorded and reported on.
- HCSO's efforts span across law enforcement jurisdictions.

What We're Seeing: Expedited Time To Charging Decision



The number of youth auto theft cases where a **charging** decision was made within 3 days increased by 18% and where a charging decision was made within 10 days increased by 24% for the period of July 1, 2023 – May 31, 2024 compared to the same period one year earlier.



What We're Seeing: Most Early Intervention Participants Have Had No New Charged Cases

95 were referred to social worker for services through 3.31.24*

77 young people had no new charged cases between their date of referral to services and date of most recent check for new charged cases^ (81%)

18 young people had a new charged case between their date of referral to services and date of most recent check for new charged cases^ (19%)



^{* -} Young people referred to services more recently than 3/31/24 were excluded from this new charged case analysis so that a minimum amount of time had passed between the date of referral to services and the check for new charged cases.

^{^ -} New charged cases for participants included in this analysis was most recently checked between 5/15/24 – 5/22/24.

What We're Seeing: Decreased Auto Theft in Hennepin County

- From January to May 2024, the total number of auto thefts reported or known to law enforcement in Hennepin County was 30% lower than the same period in 2023.
- This information comes from the MN BCA, using data reported to them by Hennepin County law enforcement agencies. Each agency is responsible for the accuracy, completeness, and timeliness of their data.

What We're Seeing: Decreased Auto Theft in Minneapolis

• From January 1 to June 24, 2024, the total number of auto thefts reported by the Minneapolis Police Department was 29% lower than the same period in 2023.

What We're Seeing: Fewer Youth Auto Theft Cases

- BCA's public dashboard data does not include data specific to youth auto theft cases.
- The number of cases reviewed by HCAO's Youth Prosecution Division provides an indication of youth-specific auto theft cases in Hennepin County.
- Between January to May 2024, the number of youth auto theft-related cases submitted by law enforcement that were reviewed by HCAO was 48% lower compared to the same period during 2023.
