**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-1st Degree-Great Bodily Harm**

Minnesota Statute: 609.221.1, with reference to: 609.221.1, 609.11.5(a), 609.101.2

Maximum Sentence: 20 YEARS AND/OR \$30,000

Offense Level: Felony

Offense Date (on or about): 06/01/2018

Control #(ICR#): 18012229

Charge Description: That on or about June 1, 2018, in Crystal, Hennepin County, Minnesota, IVAN GIOVANNI HERNANDEZ-ENRIQUEZ, assaulted a known adult male and inflicted great bodily harm, while using a firearm.

**COUNT II**

**Charge: Assault-2nd Degree-Dangerous Weapon**

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Charge Description: That on or about June 1, 2018 in Crystal, Hennepin County, Minnesota, IVAN GIOVANNI HERNANDEZ-ENRIQUEZ, assaulted a known adult male, while using a firearm.  
Minimum Sentence: 3 YEARS

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 1, 2018 at about 4:30 p.m., Crystal Police and other emergency personnel were dispatched to the Crystal skate park in the vicinity of 4800 Douglas Drive N., Crystal, Hennepin County, Minnesota, in response to a report of a shooting. A known adult male, Victim herein, was found bleeding profusely and with life-threatening injuries. He was transported for emergency surgery and survived.

Witnesses at the scene described a car leaving the scene and the suspect, identified as IVAN GIOVANNI HERNANDEZ-ENRIQUEZ, Defendant herein. Witnesses to the incident reported that Defendant and Victim had ongoing disputes with each other. On June 1, the two men were arguing and witnesses thought the argument might develop into a fistfight. However, Defendant pulled a handgun and fired once at Victim, then left in a vehicle described for police. One witness said Defendant, when pointing the firearm at Victim, raised and lowered the weapon, pointing it at different parts of Victim's body, until finally firing, apparently at Victim's leg.

Medical personnel reported that Victim was actually hit by a single bullet in his thigh near the hip, causing massive bleeding. Victim was unable to speak to police and was in critical condition but stabilized.

On June 4, Victim was able to be interviewed and confirmed that Defendant had shot him during what Victim believed would be a fistfight.

Later on June 1, Defendant was located at an apartment building in Crystal and arrested. In a Miranda prefaced statement, Defendant admitted he shot Victim, but said he did not intend to kill him. He identified the firearm as a 9 mm semiautomatic. Defendant said after the shooting he threw the gun in a lake.

Defendant remains in custody.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
