The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Offense Level: Felony

Charge Description: That on or about June 25, 2018, in Hennepin County, Minnesota, ANDREW ROY

HOGAN, assaulted VICTIM 1, while using or possessing a firearm.

Charge Description: That between June 25, 2018 and June 26, 2018, in Hennepin County, Minnesota, ANDREW ROY HOGAN, a parent, legal guardian, or caretaker endangered a child's person or health by intentionally or recklessly causing or permitting a child, VICTIM 3, to be placed in a situation likely to substantially harm the child's physical, emotional, or mental health or cause the child's death.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 25, 2018 at approximately 8:00 PM, New Hope police responded to a residence in New Hope, Hennepin County, Minnesota after 911 dispatch received text messages from a woman inside. The woman, hereafter VICTIM 1, had texted 911 stating that her boyfriend, later identified as ANDREW ROY HOGAN, Defendant herein, was threatening to kill her and would not let her out of the bathroom inside the residence. Victim 1 also indicated that there was a shotgun and an airsoft gun in the residence and that her two children, ages four and two, hereafter VICTIM 2 and VICTIM 3, were in the bathroom with her.

Police arrived and approached the front door of the residence. As they did so, the front door opened, and VICTIM 1 came outside. As police were about to enter the home to retrieve the children, Defendant shut the front door. Defendant refused to comply with multiple verbal commands from officers to come out of the residence. Knowing that Defendant may be armed with a shotgun, officers formed a perimeter and called for a negotiator and a SWAT Team.

While officers at the scene waited for SWAT, they were able to speak to Defendant through a front window of the home. Defendant said repeatedly that he would not come out and that police would have to come inside and shoot him. Defendant told officers that they would get "blasted" if they came inside to get him. Defendant also turned up loud music near the window and periodically screamed at officers to come get him. At one point, Defendant held one of his small children up to the window.

VICTIM 1 told police that Defendant had been drinking alcohol and was getting "amped up" when she took VICTIMS 2 and 3 upstairs to the bathroom to give them a bath. Defendant followed them upstairs, screaming that he was going to drown VICTIM 1 and then threatening to kill VICTIM 1 if she came out of the bathroom. Defendant then attempted to physically force the bathroom door open as VICTIM 1 held it shut with her body. VICTIM 1 then heard Defendant "clicking" a gun outside the bathroom door. VICTIM 1 told police that the sound was the same as when Defendant has attempted to scare and intimidate her by loading the shotgun on previous occasions. VICTIM 1 "tiptoed" downstairs after she thought police had arrived, opened the door, and followed officers' directions to come outside.

The SWAT Team arrived at the scene and set up outside the residence. For the next 18 hours, SWAT members attempted repeatedly to make contact and negotiate with Defendant. Defendant refused multiple times to come out of the home or to send the children outside. At approximately 9:41 PM, Defendant told SWAT officers outside the home, "I'll blow your heads off." Four minutes later, officers could hear the children crying inside the residence and Defendant yelling at them. At approximately 10:26 PM, Defendant again threatened to shoot officers outside. Finally, at approximately 2:22 PM the next day, Defendant came out the back door of the home and was taken into custody. VICTIM 2 and VICTIM 3 were located inside by law enforcement and reunited with their mother. A 12 gauge shotgun was found and seized from a downstairs bedroom along with a CO2 BB pistol.

Defendant is in custody.

The State will seek an aggravated sentence on the following ground: Counts 1-3 were committed in the presence of two young children, and Defendant gratuitously increased VICTIM 1's fear and distress by engaging in an 18-hour stand-off with police.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
