STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 2, 2018, at approximately 7:45 p.m., Minneapolis Police Officers responded to a shooting at Little Earth Housing Complex located in the city of Minneapolis, Hennepin County, Minnesota. Responding officers encountered a chaotic scene of over 50 people, which included six people who were struck by gunfire. Two of those people remain in critical condition at the time of drafting this complaint.

Responding officers and investigators recovered multiple discharged cartridge casings from the scene and spoke to numerous witnesses. They recovered several firearms, including an assault-style rifle. Video surveillance shows three gunmen, who were all identified.

Two of the people with guns can actually be seen firing their weapons. The two who can be seen firing their weapons are RICO DANIEL RAY KING [(D.O.B. 10/23/1996); ("King")]; and a 14-year-old juvenile who was fully identified in police reports.

The third gunman is the one who appeared to be carrying an assault-style rifle. Fortunately, when the shooting began, it appears he was unable to get the firearm out from under his clothing.

During the aftermath of the shooting, GEORGINA JENE KELLUM [(D.O.B. 1/21/1983); ("Kellum")] obtained the firearm used by the juvenile. When Kellum was being booked into the jail, a firearm was recovered from her person. Before recovering the firearm, Kellum lied to investigators about having a gun or knowing about a gun.

The investigation is ongoing. Two of the victims remain in critical condition. King is currently in custody and poses a significant risk to public safety.

The State will seek an upward departure given the greater than normal danger to the public.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
