The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 03/25/2018

Control #(ICR#): 18094391

Charge Description: That on or about March 25, 2018, in Hennepin County, Minnesota, JUAN ANTONIO VASQUEZ, JR., caused the death of Victim 1, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Charge Description: That on or about March 25, 2018, in Hennepin County, Minnesota, JUAN ANTONIO VASQUEZ, JR. possessed ammunition or a firearm and JUAN ANTONIO VASQUEZ, JR. has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Burglary in the First Degree on October 5, 2016, for which the sentence or court supervision expired on or after August 1, 1993.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about March 25, 2018, shortly after midnight, police received a ShotSpotter activation for the area of 2400 Ogema Place, Minneapolis, Hennepin County, Minnesota. Multiple squads and emergency medical technicians responded. The call was quickly amended to a report of a shooting. Upon arrival, officers located an unresponsive, young adult male on the steps of a residence. The male, whose initials are A.M.L., was later fully identified. He is referred to herein as Victim 1. Officers observed apparent gunshot wounds on Victim 1's upper body. Despite life-saving efforts, Victim 1 died on the scene. Another male, a juvenile who is fully identified in police reports and identified herein as Victim 2, was located and transported to the hospital. Victim 2 suffered shrapnel-type injuries to his legs, face and head. At this time, Victim 2's injuries are not considered life-threatening.

In the course of the investigation, which included a review of high quality surveillance video, officers learned that a group of young people, including Victim 1 and Victim 2, had gathered on the sidewalk outside a residence at Ogema Place. The group observed two males walking toward them. The two males are markedly different in stature and appearance. Witnesses positively identified JUAN ANTONIO VASQUEZ, JR., Defendant herein, as one of the approaching males. As Defendant and the other male approached, Victim 1 attempted to enter a residence, but was unable to do so. Defendant exchanged a few words with the group and attempted to exchange words with Victim 1. Defendant then walked up to Victim 1 and peered directly at his face. Defendant removed a firearm from his waistband, pointed the gun directly at Victim 1, and shot Victim 1 multiple times. Victim 2 was in close proximity to Victim 1 when Defendant repeatedly fired the gun. Video surveillance captured the shooting. The video surveillance is consistent with witnesses' descriptions of the shooting. After shooting Victim 1 multiple times, Defendant ran from the area, with the other male. Witnesses provided detailed clothing and physical descriptions of the Defendant and the male that accompanied him. Witnesses have also described the Defendant's firearm.

Crime scene investigators processed the scene and located more than a dozen cartridge casings in the area where Defendant was observed shooting the victim.

The Office of the Hennepin County Medical Examiner conducted an autopsy on the body of A.M.L. and determined that the manner of death was homicide, and the cause of death was multiple gunshot wounds.

On October 5, 2016, Defendant was adjudicated delinquent as an extended jurisdiction juvenile on a felony charge of Burglary in the First Degree, a crime of violence. Defendant is therefore prohibited from possessing a firearm.

Defendant has ties to several counties outside of the metro area, as well as the State of North Dakota. His current whereabouts are unknown. A warrant is requested given the significant risk to public safety and flight risk. The investigation is ongoing.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
