[AUTOMATED VOICE: November 10, 2017, 5:06:30 p.m.]

DISPATCH:

Police and Fire, 911.

KARI SNELL:

Hi, I have to report an emergency at my parents' house.

DISPATCH:

And what's the address?

KARI SNELL:

5128 Angeline Avenue West.

DISPATCH:

What city is that in?

KARI SNELL:

Crystal.

DISPATCH:

5128?

KARI SNELL:

Yup.

DISPATCH:

And what's going on there?

KARI SNELL:

My um step-dad, he found his deceased brother on Monday night and he's been going back and forth to the hospital and he's kinda losing it, he's on the phone right now with his nurse telling the nurse to call 911 'cause he's got

two guns up to his head and he's gonna shoot himself at his house...

DISPATCH:

Okay, what's his name?

KARI SNELL:

Ronald Klitzka.

DISPATCH:

Spell that for me.

KARI SNELL:

K-l-i-t-z-k-a.

DISPATCH:

And you have him on the phone right now?

KARI SNELL:

I don't, I was just on the phone with my mom who's in the house, I heard a

bunch of stuff going on and I just told my mom, I said...

[Phone static]

KARI SNELL:

Get in the car and leave.

DISPATCH:

Okay. What's a num – phone number inside the house?

KARI SNELL:

Inside the house?

DISPATCH:

Yeah.

KARI SNELL:

It's 763-421-6021.

And is your mom outta there yet?

KARI SNELL:

I just hung up from my cell phone, I told my mom I'm calling 911 and that I'm on my way there and I told my mom do not go back in the house until you see cop cars there. My mom's pretty shooken up and I'm hoping she got out

of the house.

DISPATCH:

Okay, what - what is your name?

KARI SNELL:

My name is Kari, K-a-r-i, last name is Snell, S-n...

DISPATCH:

And give me a phone number you can be reached at?

KARI SNELL:

My cell phone number is 612-296-3224.

DISPATCH:

And what kind of guns does he have?

KARI SNELL:

You know what, I have most of these guns in my house that I wanna say he

has a revolver and I wanna say a 9-millimeter.

DISPATCH:

So two revolvers?

KARI SNELL:

Uh two guns. One I always call like a cowboy gun.

DISPATCH:

Okay.

KARI SNELL:

And he honestly told my mom – I didn't hear it, but my mom says he wants the cops to come there, he wants to just be shot. And, I mean, he knows a police officer from – well it's a childhood friend of mine, I don't know if Doug Leslin could call my step-dad on the phone. I think he's chief of

Crystal.

DISPATCH: KARI SNELL: Okay, I'll send some people over – oh, what kind of car is your mother in? My mom is gonna be most likely in her red Buick, it has personalized plates that say Klitzka. And she said she was gonna just pull out and go park about a block away.

DISPATCH:

Did she say which direction she was going?

KARI SNELL:

I...

DISPATCH:

It's a cul-de-sac, isn't it?

KARI SNELL:

Uh – huh?

DISPATCH:

Is that a cul-de-sac?

KARI SNELL:

Yes, that's...

DISPATCH:

Okav.

KARI SNELL:

A cul-de-sac, so she's just gonna go at the end. I drive a Ford Expedition and

it's like sage color green with uh tan trim.

DISPATCH:

Are you there?

KARI SNELL:

No, I'm at home in Champlin right now, but...

Okay.

KARI SNELL:

I'm gonna leave here...

DISPATCH:

I'll send some people over.

KARI SNELL:

Okay, thank you.

DISPATCH:

Yup, bye.

KARI SNELL:

Bye.

[End of call]

DISPATCH:

911, what is the address of your emergency?

EPPD:

Hi, it's Eden Prairie with a transfer...

DISPATCH:

Uh [inaudible].

EPPD:

For Crystal.

DISPATCH:

All right, thank you.

EPPD:

Um-hmm. Go ahead, ma'am.

CALLER:

Hi, um I'm calling um – uh the address is 5128 Angeline Avenue, um Ronald um Klit – Klitza, he was a former hosp – hospice patient of mine, he called on-call, he says he has an arsenal of assault weapons and he wants to die today either by self-inflicted gunshot wounds or when the police come to his house.

He's going to shoot and die by police fire.

DISPATCH:

Okay.

CALLER:

And I don't know this man, he was discharged from our hospice program a while back, but I've just been on the phone with him for quite a while trying to get the address from him and that's his – this is the address we found um in

his old records.

DISPATCH:

Okay.

CALLER:

He sounds – he sounds not stable. I don't – he – at one point he told me his wife was in the house with him and then at one point he said no one, I - I'm

not really sure exactly what's...

DISPATCH:

I can take it...

CALLER:

Going on.

DISPATCH:

Okay. All right, what was your name?

CALLER:

My name is Nicki.

DISPATCH:

Yeah, I got it. And what is a call-back number for you?

CALLER:

Uh 612-720-0591.

I'm sorry, what - it was 612...

CALLER:

720-0591.

DISPATCH:

All right, we have...

CALLER:

So I still...

DISPATCH:

Help on the way out there.

CALLER:

I still – I have him on the other line, should I - I - I don't really know what to say to him, I'm on a different phone right now, he's still on the line with me,

should I stay on the line with him?

DISPATCH:

Um yes, let me...

CALLER:

Okay.

[Police radio chatter]

DISPATCH:

One second, let me – I'm just gonna talk to my officers here.

CALLER:

Okay.

[Police radio]:

Why don't you just stay back and try to figure out what we got, we talked to the mom or the – the wife [inaudible] but we have officers on 53rd [inaudible] and then Angeline is gonna continue on the other side of the park to the left of the – go down Scott to 53rd and Angeline is in that area, we'll get everybody to the north and to the left, I'll be coming in from the east [inaudible] go from

there...

CALLER:

Ronald, are you still there?

DISPATCH:

Is he still talking to you?

CALLER:

Well something – my phone has gone black and I can hear him laughing in the background a little bit, but he's not responding to anything I'm saying, but...

DISPATCH:

Okay.

CALLER:

My screen is black, so I'm not even sure I'm – if I'm connected but I – every

once in a while I think I hear him. Ronald, are you still there? No, I think

I've lost him.

[Police radio chatter]

DISPATCH:

Okay, one second.

CALLER:

Um-hmm.

[Police radio chatter]

CALLER:

Ronald?

Mother is around or is it just his wife?

CALLER:

He was just saying his wife – he was telling me...

[Police radio chatter]

CALLER:

That he killed his brother, he killed his mother um he's just not – not rational,

and I - I don't know him.

DISPATCH:

Okav.

CALLER:

He said his wife was in the house at one point, but...

DISPATCH:

Okay.

CALLER:

She wasn't – she wasn't in the room with him. He said – he said she was in a

different room.

DISPATCH:

Okay. Can you still hear him at all or no?

[Police radio chatter]

CALLER:

I can't, no.

DISPATCH:

Okay. All right, if he gets back on the phone with you, give us a call back...

CALLER:

Yup.

DISPATCH:

Here, okay?

CALLER:

Okay, I will.

DISPATCH:

All right, thank you.

CALLER:

Okay, thank you.

DISPATCH:

Yup, bye.

[End of call]

DISPATCH:

Hennepin 911, what is the address of your emergency?

[Inaudible talking in background]

UNKNOWN:

I'm calling with a request to transfer.

DISPATCH:

Thanks. Can I help you?

CALLER:

Hi, yeah, I just called about an emergency in Crystal, about a gentleman in his

home with guns and I - I have him back on the phone and they – they asked if I would call back if I got him back on the phone, so I guess that's what I'm

doing.

DISPATCH: Okay. Are – is somebody speaking to him now or are you speaking to him

or...

CALLER: No, I – I mean it's me, I don't know, I think the police are on their way, but I

just have him on my other phone.

DISPATCH: Okay. Yup, the police are on their way there, um...

CALLER: Okay.

DISPATCH: So...

CALLER: Okay. Okay.

DISPATCH: Is he...

CALLER: I - I don't know...

DISPATCH: Saying anything new or...

CALLER: No, no, just that when the police come he's gonna – he's gonna shoot 'em

through the door and blow the whole house up. Ronald, the police are on their way. So I - I don't know if I should stay on the line, if I should - I should...

DISPATCH: Yeah, if you can keep him on the line...

CALLER: [Inaudible-talkover]...

DISPATCH: And talking and – you know, and see if...

CALLER: Okay.

DISPATCH: Something set him off or, you know...

CALLER: Okay.

DISPATCH: What happened today that brought him to this point?

CALLER: Okay. Okay. Ronald – Ronald, what's going on? There's a lot of yelling.

Ronald, are you okay? Can you tell me what's going on? Ronald? I know that you're up -I - I - and I know that you're up - yeah, yeah, did - did something happen today? What happened today? You killed your brother a couple days ago? How did that happen? He shot himself in the head with your gun? Well I'm - I'm sorry to hear that, that's - that's very unfortunate.

So – what's that? Okay, well...

DISPATCH: Can you verify Ronald's phone number for me?

CALLER: Um yeah, I can...

DISPATCH: Is – is it the 421...

CALLER: I know, Ronald.

DISPATCH: Is it the 421...

CALLER: I know, Ronald, hang on.

6021?

CALLER:

Uh I gotta run downstairs. [Inaudible] I have a number of 763-537-2722.

DISPATCH:

Okay, and that's what's on Caller ID.

CALLER:

Uh nope, that was – um one of my nurses looked in our – uh in our computer system and found that phone number 'cause I'm connected with him through

our on-call hospice company...

DISPATCH:

Oh gotcha.

CALLER:

Or on-call [inaudible], so I don't have a...

DISPATCH:

Yeah, okay. Okay.

CALLER:

Nope, Ronald, hang – hang on there, hang on there with me. We've been – we've been talking for a while so let's keep talking. Okay? Is anyone in the house with you, Ronald? Was – your wife was in the house with you, she's not anymore? She's not answering, is she in a different part of the house or do you think she left? The house is small so – okay, I know and I - I'm trying to get a hold of Jacob um and I know that's who you have a relationship with so we're – we're working on that. Well, I'm - I - I'm so sorry you feel that way. Well...

[Inaudible talking in background]

CALLER:

I - well I'd uh - what - say that again.

[Inaudible talking in background]

CALLER:

Don't plan on answering the door or talking to the police when they get there? [Inaudible]. You – you want a western shoot-out with the police? All right, well it sounds like it's been – I – you didn't – it sounds like it's been a hard – a hard time for you lately. Yeah, I - I - I - I can't even imagine. You - you have a what? You're - you're drinking too? Okay. Okay. Well, was um – can you tell me why you're yelling? Okay Ronald, you killed – how did you – what's your – hmm, what happened to your mother? I'm – I'm very sorry, that – that must be hard to, hard to – to talk of. Gonna fight till the end?

[Inaudible talking in background]

CALLER:

You've got an automatic gun, a 9-millimeter and a 45 Colt? Oh. You have an M14? 308 caliber? Okay. I'm not – I'm not familiar with guns so I - I don't really know what any of that means, but it sounds – sounds like a lot. No, no, you – you – I know you don't wanna hurt people and we don't want you to get hurt either. And you said you – you haven't heard from your wife lately? Is – is she there? She doesn't answer because she knows you? 'Cause she knows you have all those guns with you? She does? Okay. Okay. I-I-I can under...

[Inaudible talking in background]

CALLER:

I – well, nobody wants you to do that, Ronald we want you just to hang in

there so we can help you.

[Inaudible talking in background]

CALLER:

I know – I – we, well – yeah, I – it's – yeah. Oh Ronald, I'm so sorry that

happened. How old was your brother?

[Inaudible talking in background]

CALLER:

Okay, well that was – that was his choice, that wasn't your fault, Ronald.

Yeah. Okay.

[Inaudible talking in background]

CALLER:

Okay, well I - I don't want you to - I don't want you to shoot those guns at any point. They're - they're coming to help you. That's not what they're coming for, they - they wanna come and help you so that we can help get this

situation...

[Inaudible talking in background]

CALLER:

Well and I – you don't – I don't want you to get that kind of courage, I want you to stay on the phone with me until we can get you the help. Um no, then you've got – you've got a wife to think about. She doesn't – I'm sure she doesn't want that to happen.

[Inaudible talking in background]

CALLER:

There's a back window? What – where – what – what – tell me about the

back window. That's the only way they can get in? Well what...

[Inaudible talking in background]

CALLER:

You have no lights on in the house at all? None in your room? How many

rooms are there in the house?

[Inaudible talking in background]

CALLER:

The last window on the back side of the house that's where you are? Okay.

Where's the...

[Inaudible talking in background]

CALLER:

Because – I didn't catch that.

[Inaudible talking in background]

CALLER:

Oh you have more power than they do? Oh as far as guns? Okay.

[Inaudible talking in background]

CALLER:

Well we don't – we don't want this to be a slaughterhouse, that's – that's not

the – that's not the goal here.

[Inaudible talking in background]

CALLER:

I − I understand that, I − I can understand why you feel that way, you've been

through a lot in the last couple days. Um-hmm.

[Inaudible talking in background]

CALLER:

Well I – I don't want you to hang up, Ronald, let's keep talking, we've been

on the phone for a while now, we can still keep talking. Oh – he hung up.

DISPATCH:

Okay.

CALLER:

Oh my, gosh, I don't -I...

DISPATCH:

Okay. Okay, yup, if he calls back go ahead and – and give us a call back.

Thank you for relaying...

CALLER:

Okay.

DISPATCH:

The information that he was giving you and repeating it.

CALLER:

Okay, thank you...

DISPATCH:

All right?

CALLER:

All right.

DISPATCH:

Thank you very much.

CALLER:

Okay.

DISPATCH:

All right, bye-bye.

CALLER:

Bye.

[End of call]

DISPATCH:

911, what is the address of your emergency?


RONALD KLITZKA: Okay, listen careful, this is – the cops have surrounded my house. I'm

Hennepin County Police and Fire, this is Colleen.

OFFICER:

Hi Colleen, its [inaudible] 09.

DISPATCH:

Yeah?

OFFICER:

Hey, we just have some information for the officers down at Crystal, we've got a phone number for the Ronald Klitzka guy, if you guys could just maybe add it to the call um and maybe let their command know. Uh we – he killed – or his brother killed himself up in our city last week so [inaudible-talkover]...

DISPATCH:

We were just talking about that, I was working that day.

OFFICER:

Yeah, so the phone number we've got is 763-537-2722, that's a cell phone he

gave for himself last week, so...

DISPATCH:

That – okay, let me see here, I know that I saw – I know I saw some phone numbers for him, possible cell – nope, that's not the same one. I know you

guys have been busy the last couple days.

OFFICER:

Seems like it's been slow.

DISPATCH:

Well you guys had the acc – you had the 14-year old girl with the cerebral

palsy...

OFFICER:

Oh [inaudible] yeah...

DISPATCH:

The 3-year old and then this guy...

OFFICER:

Yup, no...

That shot himself, yeah, see I – this'll tell you I've been here every day.

OFFICER:

Blends together after a while.

DISPATCH:

It does. Okay, so 763-537-2722 and that's the phone number Ronald gave

you?

OFFICER:

Yup, that's it.

DISPATCH:

Okay. I will let them know, okay?

OFFICER:

All right, thank you.

DISPATCH:

Thanks, bye-bye.

[End of call]

DISPATCH:

Hennepin 911, what's the address of the emergency?

RONALD KLITZKA: 5128 Angeline Avenue North, Crystal, Minnesota.

DISPATCH:

Okay.

RONALD KLITZKA: You have a homimi – listen to me very carefully...

DISPATCH:

Uh-huh.

RONALD KLITZKA: You have a hime – I can't even talk, you have a homicidal maniac...

DISPATCH:

Okay.

RONALD KLITZKA: In control of guns who's gonna shoot every fucking person he sees till he

gets fucking killed.

DISPATCH:

Oh okay, well who am I talking to?

RONALD KLITZKA: You're talking to the asshole.

DISPATCH:

Oh I don't know who you are.

RONALD KLITZKA: Ronald Klitzka, come on! You've been called three times [inaudible]

won't fucking come here 'cause they know how God-damn good I am at what

I do.

DISPATCH:

Okay. Well Ronald, I didn't talk to you so can you tell me what's going on?

[Police radio chatter]

RONALD KLITZKA: I killed my mother, I killed my fucking son and I just killed my brother.

DISPATCH:

Okay, are they in the house there with you?

RONALD KLITZKA: No.

DISPATCH: Okay, when did that happen?

RONALD KLITZKA: My brother died a couple days ago, I found him with his brains blew out because I wouldn't borrow him a thousand fuckin' dollars [inaudible] he

needed it.

DISPATCH: Okay.

RONALD KLITZKA: My son died because I didn't fucking get there to take him for the weekend I was supposed to.

[Police radio chatter]

RONALD KLITZKA: My mother died because my fucking step-father beat her to death.

DISPATCH: Okay. Well I...

RONALD KLITZKA: [Inaudible/screaming] hell!

DISPATCH: Okay, well I'm sorry to hear that, Ronald.

RONALD KLITZKA: So let's get this straight, I want you to understand something I'm going

outside and I'm loaded for fucking death. If I see any son of a bitch on the

street I'm gonna shoot 'em dead.

DISPATCH: Okay, well Ronald...

RONALD KLITZKA: Do you understand what I just said?

DISPATCH: I do, Ronald. RONALD KLITZKA: Yes or no?

DISPATCH: Ronald, I do.

RONALD KLITZKA: Yes or no?

DISPATCH: Ronald, I do, okay? And I want you to talk...

RONALD KLITZKA: So you better get somebody over here to kill me.

DISPATCH: Okay.

RONALD KLITZKA: 'Cause I will kill innocent fuckin' people to die.

DISPATCH: Okay, well guess what, Ronald, I wanna help you out and I wanna put

somebody...

RONALD KLITZKA: There's not a God-damn thing you can do. You ain't God.

DISPATCH: No, I'm not, but I'm listening and I'm trying to help you out and I want you to

talk to Officer Tourville to see if he can help you out, okay?

RONALD KLITZKA: Fuck...

DISPATCH: Why can't...

RONALD KLITZKA: Fuck this shit!

Okay, well he's – he's here to help, okay, Ronald?

RONALD KLITZKA: I [inaudible] help, I'm an ex-fucking combat Marine.

DISPATCH:

Okay.

RONALD KLITZKA: I seen my brother with his head fucking blown off because I wouldn't

borrow him a thousand fucking dollars!

[Police radio chatter]

DISPATCH:

Okay. Well do you know that that's the truth?

RONALD KLITZKA: You're God-damn right!

DISPATCH:

Why?

RONALD KLITZKA: 'Cause he talks to me.

DISPATCH:

Okay, 'cause he...

RONALD KLITZKA: And then boom! [Inaudible] fucking [inaudible]...

[Police radio chatter]

DISPATCH:

Okay. Well you know, I - I don't know if you can blame that on yourself or

RONALD KLITZKA: I am, so God-damn get 'em down here with fucking armored fucking shit

because I got enough for a fucking war!

[Police radio chatter]

DISPATCH:

Okay. Well - well, you know, he's my concern, Ronald, I don't want you to

hurt yourself or hurt anybody else.

RONALD KLITZKA: I need to die one fucking way or the other, if I've gotta shoot some fucking innocent son of a bitch I will fucking do it!

DISPATCH:

Why would you do that to somebody innocent?

RONALD KLITZKA: 'Cause I wanna fucking die, do you not understand what I'm fucking

saying?

DISPATCH:

Okay, I understand you're very upset and you're very angry and I'm sorry to

hear that. Okay? But I don't think anything in this right now is your fault and

we're trying to help you.

RONALD KLITZKA: Listen to me young lady...

DISPATCH:

I'm listening to you, Ronald.

RONALD KLITZKA: And let's be careful, my brother didn't have a God-damn thing in this

world but me and he depended on me and I didn't come through for him.

DISPATCH: Okay.

RONALD KLITZKA: So get your fucking cavalry over here or I'm gonna start shooting

fucking neighbors.

DISPATCH:

No, I don't want you to...

[Beeping noise]

DISPATCH:

Shoot your neighbors.

[End of call]

DISPATCH:

Hennepin 911, what's the address of the emergency?

PEGGY HAMILTON: Do you know its Angelina Lane in Crystal?

DISPATCH:

Um-hmm.

PEGGY HAMILTON: I don't know, it's my brother, he just called me...

DISPATCH:

Um-hmm.

PEGGY HAMILTON: Ronald Klitzka.

DISPATCH:

Yeah?

PEGGY HAMILTON: And he's gonna commit suicide or shoot up everybody and I'm in

Willmar here and I don't – I don't know if it's true or not, my other brother he

committed suicide.

DISPATCH:

Um-hmm.

PEGGY HAMILTON: I'm scared.

DISPATCH:

Okay, yup, unfortunately...

PEGGY HAMILTON: Is – is the SWAT team out there?

DISPATCH:

Yes, they are.

PEGGY HAMILTON: They are? Oh my God...

DISPATCH:

Yes, um-hmm.

PEGGY HAMILTON: Oh God! I heard him screaming, did they get him?

DISPATCH:

I – I have no idea, he hung up on me, I was just speaking with him.

PEGGY HAMILTON: Oh you were? So was I...

DISPATCH:

Right.

PEGGY HAMILTON: So was I and he [inaudible-talkover]...

DISPATCH:

I literally just hung up with him...

PEGGY HAMILTON: [Inaudible-talkover]...

DISPATCH: Five seconds ago.

PEGGY HAMILTON: Can you – are you gonna call him back?

DISPATCH: I - I - I...

PEGGY HAMILTON: Ya'll di – don't do nothing...

DISPATCH: Ma'am – ma'am, hold on, we – okay, well he's making threats and he has

guns, we have to protect everybody, okay?

PEGGY HAMILTON: Oh I know, I know that, but I want – yeah, yeah, I understand that, but I

just – that's what I wanted – that's why I'm calling, I wanted to know

[inaudible-talkover]...

DISPATCH: Okay, and all's I can do right now, we're extremely busy, we dispatch for

thirty-some police departments. I have numerous agencies out there they're

handling the situation...

PEGGY HAMILTON: Okay.

DISPATCH: That's all I can advise you of right now, okay?

PEGGY HAMILTON: Okay, okay.

DISPATCH: All right.

PEGGY HAMILTON: I just – I'm – I'm shook up, bye.

DISPATCH: No, uh-huh, bye-bye.

[End of call]

DISPATCH: Hennepin 911, what's the address of the emergency?

[Police radio]: Uh he's extremely agitated, uh we're almost to the uh...

JOSH HAMILTON: I'm not sure, okay, this is Josh Hamilton...

[Police radio]: The entrance to the garage [inaudible-talkover]...

JOSH HAMILTON: We got Ron on the phone again. Will you guys – are you guys there?

DISPATCH: Oh yeah, I told you – her sister that.

JOSH HAMILTON: Okay.

DISPATCH: I talked to her.

JOSH HAMILTON: Okay, listen I got – listen, he's on the phone we – I'm just gonna put the

phone next to it, okay?

DISPATCH: Okay.

JOSH HAMILTON: Lis – listen.

RONALD KLITZKA: [Inaudible/screaming] fucking live.

JOSH HAMILTON: Why do you wanna do that? Huh?

RONALD KLITZKA: I [inaudible] fucking to live. You sons of bitches wanna fight with me,

the whole world can fight with me, I don't give a damn! I didn't do

[inaudible]!

JOSH HAMILTON: You didn't do nothing, Ron.

RONALD KLITZKA: Here it comes again.

JOSH HAMILTON: What? Ron, don't do nothin' stupid.

[Police radio chatter]

RONALD KLITZKA: I'm gonna blow the place [inaudible-talkover]...

[Screaming in background]

RONALD KLITZKA: [Inaudible].

[Screaming in background]

JOSH HAMILTON: Don't...

RONALD KLITZKA: [Inaudible] and I tried my fuckin' best.

[Police radio]: He's outside the garage. [Inaudible].

JOSH HAMILTON: Hello?

DISPATCH: Yup, I'm here.

JOSH HAMILTON: Did you hear that?

DISPATCH: No.

JOSH HAMILTON: You couldn't hear that?

DISPATCH: I can – I can hear him screaming, but I can't make out exactly what he's

saying.

JOSH HAMILTON: But you guys are there or going back there?

DISPATCH: They have been out there, I told your sister...

JOSH HAMILTON: Oh they have been out there...

DISPATCH: I – who am I speaking with?

JOSH HAMILTON: 'Cause he's – he's saying that...

DISPATCH: I get that, what... JOSH HAMILTON: [Inaudible].

DISPATCH: What – what is your name?

JOSH HAMILTON: I'm Josh.

DISPATCH: And who are you and what – how are you related?

JOSH HAMILTON: I'm his nephew.

DISPATCH: Okay.

JOSH HAMILTON: And we're in Willmar.

[Police radio chatter]

JOSH HAMILTON: But um...

DISPATCH: Yup, I got that, we've been out...

JOSH HAMILTON: My other uncle just committed suicide here [inaudible-talkover]...

DISPATCH: I - yup, I'm very familiar with that, I dispatch for the city...

JOSH HAMILTON: Okay.

DISPATCH: Of Brooklyn Park, we're very familiar with what's going on.

JOSH HAMILTON: Okay.

DISPATCH: We've been out there for over an hour, okay?

JOSH HAMILTON: God, this is just too much.

DISPATCH: All right, it sounds like you guys have been through a lot.

JOSH HAMILTON: Yeah.

DISPATCH: Yes, um...

JOSH HAMILTON: Now – and he calls here all crazy like this we – I mean my mom can't take

this.

DISPATCH: Right. Okay, so you're...

JOSH HAMILTON: No one can.

DISPATCH: So your mom is alive?

JOSH HAMILTON: Yes, my mom's – yeah.

DISPATCH: Okay, your mom or his mom?

JOSH HAMILTON: My mom.

him.

DISPATCH: Um that's all I can tell you. I'm not there so I don't wanna misguide you and

give you any information that's incorrect, okay?

DISPATCH: All right.

JOSH HAMILTON: If whatever – I mean can you guys at least let us know something?

DISPATCH: I - I - I can't guarantee that, I dispatch for thirty-some police departments,

they're one city...

JOSH HAMILTON: I know you do...

DISPATCH: So, you know, I put all your information in the call.

JOSH HAMILTON: Okay, [inaudible] thank you.

DISPATCH: Uh-huh, you're welcome.

DISPATCH: Hennepin 911, what is the address of your emergency?

BRENDA LEWIS: It's – this is not an emergency.

DISPATCH: Thank you.

BRENDA LEWIS: Okay, um this is not an emergency or I'm not sure what's going on, my

mom just called me and she said my uncle's going crazy on Angeline Lane

and I need to know what's going on.

Okay, what's the address there?

BRENDA LEWIS: I – I don't know – I don't know, I just know it's Angeline Lane and it's

Ronnie and Nellie Klitzka are the people involved.

DISPATCH:

Okay. The police are out there and they are code 4...

BRENDA LEWIS: Okay.

DISPATCH:

Which means that everything's under control. I can have the officer on scene

call you.

BRENDA LEWIS: Okay, please.

DISPATCH:

Okay. What is your name?

BRENDA LEWIS: Um it's Brenda. Lewis is my last name.

DISPATCH:

And a phone number for you, Brenda?

BRENDA LEWIS: Um 612-246-0543.

DISPATCH:

Okay, an officer will call you soon, okay?

BRENDA LEWIS: Okay, thank you.

DISPATCH:

You're welcome, bye.

BRENDA LEWIS: Bye.
