## **Statement of Debra Ann Rice**

- Q: Okay, today's date is December 1<sup>st</sup>, 2017 at 1400 hours. Um, before we start, I want to make it clear to you that this is a voluntary statement. This is a criminal investigation into the shooting of suspect Ronald Lee Klitzka. This investigation is being conducted by the Sh- Hennepin County Sheriff's Office. So, I'm Detective Kasperek, and I'm here with...?
- A: Debbie Rice.
- Q: Could you s- um, just spell your name, s- um, say and then spell your name and date of date of birth.
- A: Debra Rice, D-E-B-R-A, R-I-C-E, 12/31/57.
- Q: Do you have a middle name?
- A: Ann, A-N-N.
- Q: Okay. [Sigh.] Okay, do you understand you're free to give a statement if you wish?
- A: Yes.
- Q: Okay. It's voluntary. Uh, the information you have may be important to this investigation, but a- deci- decision today to talk to me cannot be used against you in any employment matter. Do you understand that?
- A: Yes.
- Q: Okay. What uh, shift- what shift were you assigned to work on November 10<sup>th</sup>?
- A: Uh, it was the middle shift. We start at 11 o'clock, to 2100.
- Q: Alright. What, um, do you recall taking a call from Ronald Klitzka that day?
- A: Yes.
- Q: Okay. Do you know approximately what time it was?
- A: Um, 1757.
- Q: Okay. And how long did the phone call last, approximately?
- A: Just, I don't know if it was even thirty seconds.
- Q: Okay.
- A: Thirty seconds to a minute, maybe.

- Q: Do you recall anything he might have said?
- A: He was just very irate. Yelling. Um, top of his lungs, that he was gonna shoot himself, shoot everybody, and get shot, or. I tried to... uh, calm him down, but he wasn't even hearing me.
- Q: Didn't hear—
- A: And then he- he hung up the phone before I could even finish what I wanted to say to him.
- Q: Okay. What happened after that?
- A: Uh... I don't exactly know if he called back and he talked to another dispatcher. I was the actual manager on the East Main.
- Q: Okay.
- A: So there was somebody- my partner was taking H-Tac3, and there were other people answering phones as well.
- Q: Okay.
- A: So my main responsibility was manager on East Main.
- Q: Okay. Do you know if there were a- any other calls, being you were the manager, that may not have gotten recorded that day?
- A: No, everything would have been recorded.
- Q: Okay. Is there anything else you can think of?
- A: Nothing.
- Q: That would be pertinent? Okay.
- A: Nothing.
- Q: Okay. Alright, the time is 1406, and we're ending the interview.
