COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-3rd Degree-Substantial Bodily Harm

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 12/12/2018

Control #(ICR#): 18011052

Charge Description: That on or about 12/12/2018, in Hennepin County, Minnesota, GAVIN MITCHELL FLYNN HUTSON assaulted Victim A and inflicted substantial bodily harm.

COUNT II

Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm

Charge: Carry/Possess Pistol w/out Permit - Public Place - Gross Misdemeanor; Second or Subsequent - Felony

Maximum Sentence: 1 YEAR AND/OR \$3,000

Offense Level: Gross Misdemeanor

Charge Description: That on or about 12/12/2018, in Hennepin County, Minnesota, GAVIN MITCHELL FLYNN HUTSON held or possessed in a motor vehicle, snowmobile, or boat, or on or about his clothes or person, or otherwise possessed or controlled in a public place or area, a pistol, without first having obtained a permit to carry a pistol.

STATEMENT OF PROBABLE CAUSE

Your Complainant has investigated the facts and circumstances of the offense alleged herein, and believes the following establishes probable cause:

On December 12, 2018, officers were dispatched to Normandale Community College, located at 9700 France Avenue South, Bloomington, Hennepin County, Minnesota, on a report of an assault. Dispatch received numerous 911 calls describing an assault on a teacher in the science building. Responding officers spoke with Victim A, a teacher at the school, who reported that she had asked one of her students, GAVIN MITCHELL FLYNN HUTSON, Defendant herein, to stay after class to discuss an inappropriate comment he made during class to another student. Victim A stated that Defendant then hit her, and she fell to the ground, losing consciousness. Another witness reported that after Victim A lost consciousness, Defendant stood over her and continued punching her.

The witness yelled for help, and Victim B, another teacher at the school, came into the classroom and attempted to pull Defendant off of Victim A. Defendant hit or punched Victim B, possibly using an object of some sort, causing a laceration to the right side of Victim B's forehead. Defendant then fled from the room, leaving behind his backpack.

As Defendant fled from the classroom, he encountered Victim C, a student at the school. Victim C stated that Defendant "stiff-armed" him, and pushed him into a wall. Victim C had previously broken his wrist, and had it in a soft splint, which hit the wall when Defendant shoved him, causing pain to his wrist.

A search of the backpack left behind by Defendant revealed a .40 caliber Smith and Wesson semi-automatic pistol, which was loaded. Additional ammunition as well as documents bearing Defendant's name were also found in the backpack.

Victim A was transported to be treated for her injuries. X-rays revealed that she had two broken bones in her face.

Defendant was apprehended in nearby parking garage. When he was arrested, he had blood splattered on his hands and shirt sleeves.

Defendant is in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
