The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Terroristic Threats-Reckless Disregard Risk

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 11/19/2018

Control #(ICR#): 18047315

Charge Description: That on or about November 19, 2018, in Hennepin County, Minnesota, LLOYD EDWARD JOHNSON (DEFENDANT) did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another.

COUNT II

Charge: Carry/Possess Pistol w/out Permit - Public Place - Gross Misdemeanor; Second or Subsequent - Felony

Minnesota Statute: 624.714.1a, with reference to: 609.03.2, 624.714.1a

Maximum Sentence: 1 YEAR AND/OR \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 11/19/2018

Charge Description: That on or about November 19, 2018, in Hennepin County, Minnesota, LLOYD EDWARD JOHNSON held or possessed in a motor vehicle, snowmobile, or boat, or on or about his clothes or person, or otherwise possessed or controlled in a public place or area, a pistol, without first having obtained a permit to carry a pistol.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 19, 2018, officers were dispatched to a McDonalds located at 598 Prairie Center Drive, Eden Prairie, Hennepin County, Minnesota, on a report that a man pulled a gun on a group of teenagers but was no longer on scene.

Officers spoke with victims H.A. and A.M., both 17 years old. H.A. told police that she and A.M., were trying to use "Apple Pay" to purchase food, but the system was not working. H.A. stated that a male standing behind her started complaining and told them to hurry up. The male then said "you were probably trying to pay with EBT." H.A. turned around and verbally confronted the male about the statement. The male then approached A.M. and got into her face. A.M. described the male as balling his fist and putting her in fear that he was going to hit her. A.M. went to the dining room area to ask for help from her other friends that were at the store.

H.A. and A.M. told officers that other friends at the restaurant verbally confronted the male. H.A. stated that the male walked away from the group but then returned with his cell phone, appearing to record the argument. H.A. stated that the male then yelled at everyone to back up before pulling a handgun from his waistband and exiting the store. H.A. told police that the male did not point the handgun at anyone in the group. H.A. stated she was scared for her and her friends' safety. A.M. stated that she did not see a gun but heard several people yelling that the male had a gun.

Officers obtained short clips of the incident from cell phones. McDonald's surveillance system showed several angles of the offense; however, a manager at McDonald's was unable to immediately provide officers with a copy of any surveillance footage due to technical difficulties with the system.

Officers later identified the male as LLOYD EDWARD JOHNSON (DEFENDANT) and learned that DEFENDANT did not have a permit to carry a firearm. On November 21, 2018, officers spoke with DEFENDANT. DEFENDANT admitted that he had a handgun in his right jacket pocket when he was in the McDonalds. DEFENDANT stated he felt threatened by the group and pulled his handgun out so he could leave the restaurant. DEFENDANT stated he did not point the gun but may have waived it. DEFENDANT admitted to making a statement about one of the girls using an EBT card and stated "that was an insult, I shouldn't have said that." DEFENDANT admitted he did not have a permit to carry the firearm. DEFENDANT stated that the gun he used was inside of his car.

Officers recovered a black STEYR M40 semi-automatic handgun in between the two front seats of DEFENDANT's car. The gun had a magazine loaded with 10 rounds of ammunition but did not have a round in the chamber.

Copies of all McDonald's surveillance footage was provided to officers on November 28, 2018. A review of the footage shows DEFENDANT standing against a wall in front of the ordering counter while H.A. and A.M. are at the counter attempting to pay. DEFENDANT says something to H.A. and A.M., which causes them to look back. As H.A. and A.M. leave the counter, DEFENDANT points and quickly approaches A.M., getting close to her face. Another male turns around from the counter and approaches DEFENDANT. DEFENDANT slaps the male's hand away and assumes an aggressive posture while keeping his right hand in his right jacket pocket. DEFENDANT then backs away for a moment before taking out his cell phone and reengaging the group. As more students come from the dining area to the counter area, DEFENDANT backs away while pulling out a gun from this right jacket pocket. Once the gun is out, the

group quickly scatters in different directions while DEFENDANT leaves the restaurant.

DEFENDANT is out of custody.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
