The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Burglary-2nd Degree-Dwelling

Minnesota Statute: 609.582.2(a)(1), with reference to: 609.05.1, 609.05.2, 609.582.2(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 12/10/2015

Charge Description: That on or about December 10, 2015, in Minneapolis, Hennepin County, Minnesota, ELIZABETH ROSE OSTERBAUER, either directly or as an accomplice, acting alone or intentionally aiding, advising, hiring,

counseling or conspiring with another, or otherwise procures the other to commit the crime, entered a dwelling without consent, and with intent to commit a crime or committed a crime, while in the building.

Charge: Overwork/Mistreat Animals-Torture

Charge Description: That on or about 12/10/2015, in Hennepin County, Minnesota, ELIZABETH ROSE OSTERBAUER did overdrive, overload, torture, cruelly beat, neglect, or unjustifiably injure, maim, mutilate, or kill an animal, or cruelly work an animal when it was unfit for labor.

COUNT IV

Charge: Stalking - Pattern of Stalking Conduct

Minnesota Statute: 609.749.5(a), with reference to: 609.749.5(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Charge Description: That on or about 6/5/2016, in Hennepin County, Minnesota, ELIZABETH ROSE OSTERBAUER engaged in a pattern of stalking conduct with respect to victim and/or members of the victim's household in a manner that would cause a reasonable person under the circumstances to feel terrorized or to fear bodily harm and that did cause this reaction on the part of the victim.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 6, 2016, Minneapolis Police went to a residence on the 3500 block of Boardman Street, Minneapolis, Hennepin County, Minnesota in response to a call of a burglary. The occupant of the property, a woman with initials SAB, was out of town and having her friend, MMJ, check on the residence. MMJ told police that SAB had been trying to reestablish herself after trying to get away from defendant ELIZABETH ROSE OSTERBAUER, who had apparently been stalking SAB.

MMJ said she went to the residence and found that it had been broken into and there was kitty litter strewn all about, on the living room floor, spread into the bedroom just off the living room, the kitchen, and in the bathroom, where she noticed the toilet had been plugged with the kitty litter. The water from the toilet poured onto the floor in the bathroom, kitchen down the stairs leading to the basement and into the living room. A window was open at the back of the house. MMJ also pointed out that files on two dogs previously owned by SAB were missing. Defendant OSTERBAUER was suspected of taking those dogs the previous December in 2015.

MMJ explained that SAB and defendant OSTERBAUER had met through a dog rescue agency. She said that defendant OSTERBAUER had romantic feelings for SAB, which SAB did not reciprocate. In a phone call with SAB, she reported to police that she was fearful of defendant OSTERBAUER, which is why she had left town.

Months later, on December 13, 2016, MMJ gave a tape recorded statement to Minneapolis Police in which she admitted to having knowledge of and being present with defendant OSTERBAUER during the killing of at least one of SAB's dogs, which defendant OSTERBAUER tortured, drugged, and killed.

SAB also pointed police to another witness, MM, who told police that she was present with defendant OSTERBAUER when OSTERBAUER burglarized SAB's home on December 10, 2015. MM watched her enter the house by using a hidden key, and took SAB's dog. MM told police that defendant OSTERBAUER took the dog to a state park or wildlife refuge and killed it by stomping on it before drowning it in a marsh.

Police also spoke with another witness, ME, a man who told police that defendant OSTERBAUER had admitted stealing and killing SAB's dog. ME knew that MM had been with defendant OSTERBAUER during that first burglary on December 10, 2015. He also knew about the second burglary on or about June 6, 2015, because defendant OSTERBAUER had offered him and other friends \$1,000 to do a job for her involving SAB's house. When they refused, he believed that she convinced her brother, RO, to do it for her. She later admitted to arranging that burglary. He knew that she had taken things belonging to SAB, including a blanket, vet records and other things that meant something to her.

Defendant OSTERBAUER did not have SAB's permission to enter her home either on December 10, 2015, or June 6, 2016 or any time in between or thereafter. Defendant OSTERBAUER was located and taken into custody, where she remains.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
