COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence: 15 YEARS AND/OR \$30,000

Offense Level: Felony

Offense Date (on or about): 09/28/2018

Control #(ICR#): 18328157

Charge Description: That on or about 9/28/2018, in Hennepin County, Minnesota, Antonio Cortez Rule Jr possessed ammunition or a firearm and Antonio Cortez Rule Jr has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Simple Robbery on 2/12/2018, for which the sentence or court supervision expired on or after August 1, 1993.

Minimum Sentence: 5 YEARS

COUNT II

Charge: Assault-2nd Degree-Dangerous Weapon

Minnesota Statute: 609.222.1, with reference to: 609.222.1, 609.11.5(a), 609.101.2

Maximum Sentence: 7 YEARS AND/OR \$4,200-\$14,000

Offense Level: Felony

Offense Date (on or about): 09/28/2018

Control #(ICR#): 18328157

Charge Description: That on or about 9/28/2018, in Hennepin County, Minnesota, Antonio Cortez Rule Jr, assaulted victim, while possessing a firearm.

Minimum Sentence: 3 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about September 28, 2018 at 7:08 pm Minneapolis Police Officers were on routine patrol and they noted a group of males obstructing traffic at 808 Lowry Avenue North, Minneapolis, Hennepin County, Minnesota. Officers tried to make contact with this group of males and a male that was later identified as ANTONIO CORTEZ RULE, JR, the Defendant, refused officers commands to stop. The Defendant then began putting his hands into his waistband, a movement based on the officers' training and experience indicated he had a firearm.

The Defendant was again ordered to stop multiple times and he refused and began to sprint away from the officers. Officers gave chase on foot and the pursuit led to near homes on 30th Avenue North. When one officer reached a home the Defendant came around that home and at the officer and the Defendant had a gun drawn and was pointing it at the officer. The officer indicated he feared for his life and the officer fired one shot at the Defendant. The Defendant immediately dropped his weapon. The officer stayed with the weapon and the Defendant again ran and was apprehended in a home nearby.

The Defendant was questioned regarding the incident and he admitted to possessing the gun stating he purchased it for personal protection. When asked about when the officer shot at him the Defendant indicated he ran around the house and saw the officer and " I guess he thought I was aiming my gun at him" and the officer shot.

A review of the Defendant's criminal history indicates he was adjudicated for a Simple Robbery on 2/12/2018.
