The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Possession of Burglary or Theft Tools**

Minnesota Statute: 609.59, with reference to: 609.59

Maximum Sentence: 3 YEARS AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 02/02/2018

Control #(ICR#): 18034146

Charge Description: That on or about 2/2/2018, in Minneapolis, Hennepin County, Minnesota, DEMITRIY ALEXSANDROVICH SOKOLOV had in his possession a device, explosive or other instrumentality and intended to use it or permit its use to commit burglary or theft.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On February 2, 2018, Minneapolis Police were dispatched to Lifetime Fitness – Target Center, a health club, located at 600 1st Avenue North, Minneapolis, Hennepin County, Minnesota, on a reported theft in progress. Upon arrival, officers spoke to Lifetime employees who stated that a male, identified as DEMITRIY ALEXSANDROVICH SOKOLOV, Defendant herein, had been using the name, phone number, and identity of Victim 1, a Lifetime Fitness member, to gain access to various health clubs in the area and steal from the men's locker room. Victim 1 stated that his wallet was stolen from the men's locker room at Lifetime Fitness a few months prior. He had been notified that Defendant was using his identity to gain access to the clubs and Defendant did not have Victim 1's permission to use his identity.

Lifetime Fitness staff further reported that after using Victim 1's identity to enter the club, Defendant would then pry open various locked lockers and steal other member's possessions. Lifetime Fitness locations that were affected included Eden Prairie, Minnetonka, and Fridley. Investigation and follow up with additional victims is pending.

When police arrived on February 2, 2018, they located Defendant hiding in a men's bathroom. Defendant claimed he was there on a guest pass, however, Lifetime Fitness records indicated that was not true. Defendant had no gym bag or other workout gear with him. In his pocket was a screwdriver, a tool consistent with prying open lockers.

Defendant is currently in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
