The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Terroristic Threats-Reckless Disregard Risk

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 05/07/2019

Control #(ICR#): 19004969

Charge Description: That on or about 5/7/2019, in Hennepin County, Minnesota, ANTHONY FRANCIS ROMANO did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, Victim.

COUNT II

Charge: Terroristic Threats-Explosives/Incendiary Device

Minnesota Statute: 609.713.2, with reference to: 609.713.2

Maximum Sentence: 3 YEARS AND/OR \$3,000

Offense Level: Felony

Offense Date (on or about): 05/07/2019

Control #(ICR#): 19004969

Charge Description: That on or about 5/7/2019, in Hennepin County, Minnesota, ANTHONY FRANCIS ROMANO communicated to another, Victim, with purpose to terrorize or in a reckless disregard of the risk of such terror, that explosives were present at Victim's place of employment in Hennepin County, whether or not the same was in fact present.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 7, 2019, Hennepin County Sheriff's Deputies were dispatched to the Hennepin County Central Mobile Equipment Division (CMED) located in the City of Medina on a bomb threat made by a former employee. Upon arrival, deputies learned the following:

At approximately 10:00am, a CMED employee, hereinafter Victim, fielded a phone call from a former employee, ANTHONY FRANCIS ROMANO, DOB: 5/25/53, the Defendant. Victim knew the caller was Defendant because she worked with him for a number of years, recognized his voice, and also recognized the phone number from which he was calling. Defendant's girlfriend had also worked at CMED until very recently. Victim was aware the circumstances surrounding Defendant's girlfriend's employment situation angered Defendant. Defendant asked to speak to a human resources manager and was told by Victim that person was not available. At that time, Defendant told Victim "You better get out of the building because there's a bomb." Victim stated the comment alarmed her. Victim stated Defendant went on to state that he and his girlfriend were filing a lawsuit against Hennepin County. Defendant hung up but called back a second time shortly after his first call. During the second call Defendant told Victim there were bombs attached to the fleet of trucks outside the building. Victim reported the threat to her manager immediately.

Deputies interviewed Defendant's girlfriend who stated she was with Defendant all morning on May 7, 2019. Defendant's girlfriend admitted Defendant called CMED but stated he never made any threats. She eventually stated he did reference bombs at the facility but stated he "was only joking."

An arrest warrant was executed at Defendant's known address where Defendant was located and apprehended. Defendant is currently in custody. In a Mirandized interview, he admitted calling CMED on May 7, 2019 but denied making threats of any kind.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
