The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: Forty years.

Offense Level: Felony

Offense Date (on or about): 08/18/2019

Control #(ICR#): 19247718

Charge Description: That on or about August 18, 2019, in Hennepin County, Minnesota, DERRICK DEWAYNE BLANTON, caused the death of I.S., a human being, with intent to effect the death of that person or another, but without premeditation, while using or possessing a firearm.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about August 18, 2019, at approximately 4:07 p.m. officers with the Minneapolis Police Department were dispatched to an apartment building located at 1906 1st Avenue South, Minneapolis, Hennepin County, Minnesota, on the report of a shooting. Upon arrival, officers spoke to the reporting party M.W. M.W. informed officers she returned home to find the adult male victim I.S. lying face down on the ground in a pool of blood outside her apartment.

M.W. informed officers the victim was her ex-boyfriend. M.W. and the victim share a child in common. The victim occasionally stops by M.W.'s apartment unannounced to visit his child. M.W. is currently dating DERRICK DEWAYNE BLANTON, Defendant herein. The victim and Defendant had been feuding over M.W. On the date in question, Defendant was visiting M.W. at her apartment. M.W. left her apartment to drop her child off at her mother's apartment. Defendant remained at M.W.'s apartment. M.W. returned fifteen minutes later and discovered the victim lying on the ground outside her apartment. Defendant was no longer at her apartment. M.W. informed officers Defendant drove a black Dodge Charger.

Officers spoke to several witnesses who live in the apartment building. Several witnesses told officers they heard several gunshots. The witnesses then saw two males and a child run from the apartment building and get into a black Dodge Charger. The vehicle then sped away from the scene at a high rate of speed.

Investigators reviewed video surveillance cameras in the area. Video surveillance cameras show Defendant, an unknown male, and a young child running from the apartment building. The parties then get into a black Dodge Charger and leave the scene at a high rate of speed.

Defendant was subsequently apprehended. In a post-Miranda statement Defendant admitted to shooting the victim several times after a physical dispute. Defendant told officers he was at M.W.'s apartment with his four year old son. The victim came over to the apartment unannounced. The victim and Defendant got into a physical altercation. Defendant shot the victim several times. Defendant then fled the scene with his four year old son and friend. Defendant told officers he tossed the firearm out the window of his vehicle while he was driving in south Minneapolis.

Officers spoke with the medical examiner. The medical examiner informed officers the victim was shot five times and one of the gunshot wounds was to the victim's back.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
