**COMPLAINT**

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Prostitution-Engage 16 to 17 Yr Old**

Minnesota Statute: 609.324.1(c)(1), with reference to: 609.324.1(c)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 07/11/2001

Control #(ICR#): 19014033

Charge Description: That on or about 7/11/2001, in Minneapolis, Hennepin County, Minnesota, ROBERT SYLVESTER KELLY intentionally engaged in prostitution with an individual under the age of 18 years, but at least 16 years of age.

**COUNT II**

**Charge: Prostitution-Hire 16 to 17 Yr Old**

Minnesota Statute: 609.324.1(c)(2), with reference to: 609.324.1(c)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 07/11/2001

Control #(ICR#): 19014033

Charge Description: That on or about 7/11/2001, in Minneapolis, Hennepin County, Minnesota, ROBERT SYLVESTER KELLY intentionally hired or offered or agreed to hire Victim, an individual under the age of 18 years, but at least 16 years of age, to engage in sexual penetration or sexual contact.

## STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the Minneapolis Police Department, has investigated the facts and circumstances of the offense and believes the following establishes probable cause:

On January 11, 2019, a known adult female, hereinafter referred to as Victim, contacted a law enforcement hotline to report a sexual encounter with ROBERT SYLVESTER KELLY, the defendant herein. Victim reported that the incident occurred when she was underage and that it occurred in Minneapolis. The tip was given to law enforcement who started investigating.

Complainant interviewed Victim who reported engaging in a sexual act with the defendant for money at a time when the defendant was in Minneapolis for a concert. Victim reported that she first encountered the defendant at City Center where she saw fans getting autographs. Victim stated that she obtained an autograph from the defendant which also contained a phone number. Victim indicated that she called the number and was directed to a downtown Minneapolis hotel where she met the defendant.

Victim reported that upon entering the hotel, a man who appeared to be one of the defendant's staff brought her to the hotel suite. Victim stated that she waited for a short period of time before the defendant entered the room. The defendant and Victim engaged in small talk before the defendant gave her \$200 to dance. According to Victim, after reaching an agreement on an amount, he helped her remove her clothing. Victim stated that the defendant took off his clothes as well.

Victim reported that the defendant laid on the bed and she climbed on top of him, body to body. Victim stated that she was positioned looking down towards the defendant's feet as she danced. According to Victim, the defendant was rubbing her body as well as fondling his erect penis. Victim stated that the defendant touched all over her body including her vagina and her breasts.

Victim described how after the dance was complete, the defendant stated that he would see her at the concert and then left. Victim stated that she did attend the defendant's concert as a guest who did not have to pay or present ID and that she was close to the stage during the concert. Victim stated she was not yet 18 so she would have been unable to get into an 18+ concert with a standard ticket.

Victim reported that she saw her brother at the concert, and he was not only surprised that she was present at the concert but also how close to the stage was located. Victim stated that she told her brother about the incident with the defendant when he asked about her presence at the concert.

Complainant interviewed Victim's brother who confirmed that he saw his sister at the concert in question and that his sister did not have the money for such a ticket. Victim's brother also confirmed that his sister told him she went to the defendant's room and danced for him for money. Victim's brother stated he did not go into detail with his sister about what happened in the hotel room because Victim looked very uncomfortable discussing the matter.

Investigation into the concert, based on information provided by Victim and her brother, showed the concert in question was held July 11, 2001 in Minneapolis. Victim was 17 years old at that time.

The defendant is not in currently custody on this matter.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
