The Juvenile Court has jurisdiction by reason of the following allegations: The above-named juvenile is alleged to be delinquent pursuant to Minn. Stat. § 260B.007, Subd. 6(1) because said child has violated a state/local law as follows:

Count 1: B3764 Burglary-3rd Deg-Steal/Commit Felony or Gross Misd (Felony) (Aid/Abet)
MINN. STAT. 609.582.3, 609.582.3, 609.05.1, 609.05.2

That on or about 6/12/2019, in New Hope, Hennepin County, Minnesota, Jered Andrew Ohsman, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with H.B. or otherwise procures the other to commit the crime, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

Count 2: V0021 Theft-Take/Drive Motor Vehicle-No Owner Consent (Felony)
MINN. STAT. 609.52.2(a)(17), 609.52.3(3)(d)(v)

That on or about 6/12/2019, in St. Louis Park, Hennepin County, Minnesota, Jered Andrew Ohsman took and/or drove a motor vehicle, a Honda CRV, bearing Minnesota License Plate 147-WBY, without the consent of Victim 1, or the owner's authorized agent, and he knew or had reason to know that the owner or authorized agent did not give consent, and the property stolen is a motor vehicle.

Count 3: E2700 Fleeing a Peace Officer in a Motor Vehicle (Felony)
MINN. STAT. 609.487.3, 609.487.3

That on or about 6/12/2019, in New Hope, Hennepin County, Minnesota, Jered Andrew Ohsman did by means of a motor vehicle, flee or attempt to flee from a peace officer acting in the lawful discharge of an official duty, who Jered Andrew Ohsman knew or reasonably should have known was a peace officer.

PROBABLE CAUSE STATEMENT

Your Petitioner is an Assistant County Attorney. In that capacity, Petitioner believes the facts and circumstances recited below establish probable cause:

On June 11, 2019, at approximately 8:00 p.m., Victim 1 parked her Honda CRV, bearing Minnesota License Plate 147-WBY, in front of her residence on 28th Street, in St. Louis Park, Hennepin County, Minnesota. She had a spare key hidden inside the vehicle and she thought she had locked the doors. She did not give anyone else permission to drive her vehicle. Sometime that night, the car was stolen from in front of her house.

On June 12, 2019, at 1:45 a.m., Officers were dispatched to a cell phone store, located on Cedar Lake Road, in St. Louis Park, Hennepin County, Minnesota. The business is located about 3 miles from where Victim 1's vehicle was stolen. Officers observed that the window on the front door of the store was broken. Inside the store was broken glass and a silver colored vehicle jack. The owner of the store informed Officers that the cash register was broken into and cash was stolen along with several used cell phones that were kept in a drawer next to the register.

On June 12, 2019, at 2:26 a.m., Officers were dispatched to a second cell phone store, located on Winnetka Avenue, in New Hope, Hennepin County, Minnesota. This business is located about 5 miles from the first cell phone store. The reporting party stated that there was a burglary in progress, that a silver SUV was parked in front of the store, and that suspects were throwing things out the window of the store. As responding Officers arrived they saw a Honda CRV in front of the business. A suspect, dressed in all black, was observed running from the business, into the front passenger side of the Honda CRV, and the vehicle then speed away. Officers engaged their emergency lights and sirens and began to pursue the vehicle. The vehicle attempted to evade Officers, traveling 65 mph on local roads and refusing to pull over. After a pursuit that lasted about 2 minutes and spanned 1 mile, the vehicle turned onto the onramp for Highway 169 north. The driver lost control of the vehicle and crashed through a chain link fence. The driver attempted to drive back onto the ramp, but Officers were able to use their vehicles to prevent the vehicle from fleeing. The vehicle was the same Honda CRV, plate number 147-WBY, that was stolen in St. Louis Park earlier that night.

Officers were able to apprehend the suspects. The driver, later identified as Jared Andrew Ohsman, remained in the driver's seat. The other suspect, identified as H.B., was originally in the front passenger seat, but he had crawled to the rear driver's side in an attempt to exit the vehicle. Inside the vehicle, Officers located items stolen from at least one of the cell phone stores. Officers also located a handgun in the center console of the vehicle.

The owner of the second cell phone store confirmed that items had been stolen from his business and he provided video surveillance confirming that the passenger of the vehicle, later identified as H.B., wearing a black hooded sweatshirt, had broken the front window of the store, entered, and had stolen money and items from the store. The second suspect, Jared Andrew Ohsman, remained in the getaway car while his accomplice stole the items. Both suspects fled together.
