The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 10/30/2019

Control #(ICR#): 19326574

Charge Description: That on or about October 30, 2019, in Hennepin County, Minnesota, TAHDREONA SHANICE ANDREWS, caused the death of Victim, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 30, 2019, the Minneapolis Police Department was dispatched to the report of a deceased individual at 39XX Lyndale Ave N, Apt X, Minneapolis, Hennepin County, Minnesota.

Upon arrival officers spoke with witnesses who said they had gone to the apartment to check on TAHDREONA SHANICE ANDREWS, Defendant herein. Defendant is the resident of the apartment and witnesses reported Defendant had not communicated with them recently so they were worried about her whereabouts. Upon entering the apartment witnesses observed the deceased individual and called the police.

The deceased was later identified as Victim, a known male. Victim and Defendant have a young child together.

It was determined that Victim had minimum of three gunshot wounds.

On October 31, 2019, officers located Defendant in Hudson, Wisconsin. In a post-Miranda statement, Defendant admitted that she shot Victim on October 30, 2019.

Defendant is currently in custody in Wisconsin. The State is asking for a warrant to ensure her appearance, to protect public safety, and due to the serious nature of the charges.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
