The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 05/25/2019

Charge Description: That on or about May 25, 2019, in Hennepin County, Minnesota, SHERMEIKA NACOLE FRANKLIN, caused the death of victim, a human being, with intent to effect the death of that person or another, but without premeditation.

Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony

Charge Description: That on or about May 25, 2019, in Hennepin County, Minnesota, SHERMEIKA NACOLE FRANKLIN, did without intent to effect the death of any person, cause the death of victim, a human being, while committing or attempting to commit the felony offense of second degree assault while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 25, 2019, officers responded to 810 Hennepin Avenue South, Minneapolis, Hennepin County, Minnesota, on report of a stabbing. Upon arrival, officers found a woman, Victim, lying on the ground in the parking lot surrounded by several onlookers. Two people were applying pressure with a white t-shirt to Victim's upper left chest area. Officers removed the t-shirt and observed a single one-inch stab wound to her chest. The Victim was unconscious.

EMS transported Victim to the Hennepin County Medical Center. Officers assisted with life saving measures. Victim never regained consciousness and was pronounced deceased at 10:27 p.m. The Hennepin County Medical Examiner ruled the Victim's cause of death as a stab wound to the chest, and the manner of death as homicide.

Officers spoke with witness 1, who stated that she was with the Victim across the street from the Hawthorne Ramp when several other people arrived. Witness 1 stated that she had her back turned to Victim for about 2 to 3 minutes when she noticed the Victim fall to the ground. Witness 1 stated she initially thought the victim tripped and fell but then saw she was bleeding from her chest.

Officers received a call from Witness 2, who stated that SHERMEIKA NACOLE FRANKLIN (Defendant) called her and admitted she stabbed the Victim in the chest. Witness 2 described Defendant as a black female, approximately 4'9" tall. Witness 2 stated that Defendant carries a large purse. Witness 2 told officers that Defendant was currently a friend's apartment on Hawthorne Avenue.

Officers reviewed surveillance from a nearby bar. The description from Witness 2 was consistent with the individual on surveillance getting into an argument with the Victim. Both Victim and Defendant and circling one another for a brief period. The Victim staggers away before falling to the ground. Defendant quickly leaves the area.

Officers contacted Witness 1 and administered a photo lineup. Witness 1 identified Defendant from the group of six photographs.

Officers went to the address provided by Witness 2 and arrested Defendant. In a post-Miranda interview, Defendant stated that the victim was bothering her all day. Defendant stated that Victim punched her in the chin. Defendant admitted to pulling out a knife and stabbing the Victim once in the chest. Defendant stated that she left the area and went to a nearby Pizza Hut where she broke the knife and threw it away.

Defendant is in custody.
