The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Cond-1st Degree-Penetration/Contact - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2,

609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 11/03/2019

Control #(ICR#): 19006610

Charge Description: That on or about 11/3/2019, in Hennepin County, Minnesota, JEFFREY MORGAN GROVES engaged in sexual penetration of Victim, and caused personal injury to her using force or coercion to accomplish the act.

COUNT II

Charge: Kidnapping-To Facilitate Felony or Flight

Maximum Sentence: 20 YEARS AND/OR \$35,000

Charge Description: That on or about 11/3/2019, in Hennepin County, Minnesota, JEFFREY MORGAN GROVES removed Victim from one place to another without her consent, in order to facilitate commission of a felony or flight thereafter.

COUNT III

Charge: Burglary-1st Deg-Assault Person In Build/On Property

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Charge Description: That on or about 11/3/2019, in Hennepin County, Minnesota, JEFFREY MORGAN GROVES, either directly or as an accomplice, entered a building, without consent and with intent to commit a crime or committed a crime, while in the building and assaulted Victim, a person within the building.

STATEMENT OF PROBABLE CAUSE

Your Complainant is an Investigator with the St. Louis Park Police Department, and in that capacity has investigated the facts and circumstances of the offense alleged herein, and believes the following establishes probable cause:

On November 3, 2019, a known elderly female, Victim herein, reported to police that in the early morning hours, she had been repeatedly raped in her home, located at 2XXX Parklands Road, St. Louis Park, Hennepin County, Minnesota, by JEFFREY MORGAN GROVES, Defendant herein. Victim reported that she was sleeping in her bedroom when Defendant, who at that time was attempting to disguise his voice, jerked open her bedroom door and stated, "I'm going to get you, you f--king b---h." Defendant then ran to the bed, jumped on top of Victim, and pinned her down with his hands, ripping off her pajama top and telling her, "you know what's coming next." Defendant had brought a duffel bag with him into the room and removed a cord from the bag, tied Victim's wrists together, and placed a pillow case over her head. Defendant took pantyhose stockings from the bag and put them on Victim, and then cut the crotch out of the pantyhose with a sharp object. Defendant then penetrated Victim's vagina with his penis, while slapping her repeatedly on the groin, buttocks, and head. He positioned Victim on both her back and her stomach as he raped her; the positioning caused her considerable pain.

Defendant was smoking what he said was methamphetamine, and he raped Victim three times while he was in her residence, over the course of several hours. Eventually Defendant tied Victim's wrists and ankles together behind her back, and during the course of the sexual assaults, Defendant used his hands to hold some kind of cord against Victim's throat. Defendant later instructed Victim to "put on a sexy nightgown," and Victim told him she could not do that because she was tied up and had a pillow case over her head. Defendant then untied her and took off the pillow case, allowing Victim to confirm Defendant's identity as JEFFREY MORGAN GROVES, who Victim had once employed as a handyman.

Defendant asked Victim where she had a suitcase and where she kept cash. Victim directed him to those items, and Defendant took approximately \$400 from the pot in the kitchen where Victim kept cash, and began to fill the suitcase with Victim's clothing. Victim got dressed, and then Defendant put a ball of fabric in Victim's mouth and tied fabric around her head to hold it in place, and tied her wrists together again. Defendant then led Victim outside to his black pickup truck, and put her in the passenger seat. Defendant told her that he had a Glock handgun, and if she tried anything, he would shoot her. Defendant stopped at two ATMs, where Victim withdrew \$500 and \$300, respectively, and gave him the money. Defendant also stopped at a locked store in Minneapolis, and made her wait while he accessed the rear of the store with a key.

Defendant returned Victim to her home in the morning hours, and went inside with her, telling her he needed a drink. Defendant consumed some wine in Victim's house, and then collected the pillow cases, sheets, and comforter from Victim's bed, along with the wine bottle and glass he had been drinking from, and left Victim's house. Before leaving, Defendant apologized to Victim for raping her, and told her that "Satan" made him do it.

Victim underwent a sexual assault examination later that day. The examination revealed significant bruising over Victim's entire body, including large bruising on her thighs, bruising on her arms, ankles, and the underside of her left breast, and linear red marks on her wrists and ankles. Victim also had rib pain, soreness and swelling on the right side of her head, and redness and linear marks on her neck. In addition, Victim had broken blood vessels in her eyes, jaw soreness, and soreness and swelling in her genital region. She also had multiple tears on her labia minora, bruising on the outside of her vagina, and swelling and bleeding inside her vagina.

A search warrant was executed at Defendant's residence, an apartment located at 181 Maria Avenue, St. Paul, Ramsey County, Minnesota, on November 7, 2019. Investigators recovered several pairs of pantyhose stockings with the crotch cut out, a methamphetamine smoking pipe, and Victim's bedding.

Officers located Defendant on November 13, 2019 and attempted to conduct a traffic stop to arrest him. Defendant fled in his vehicle, and was stopped by police using a PIT maneuver, which caused his vehicle to crash. Defendant was injured and is currently hospitalized in critical condition. Victim's driver's license was found in Defendant's wallet at the time of his arrest.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
