The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.05.1, 609.05.2, 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 11/15/2019

Control #(ICR#): 19011417

Charge Description: That on or about 11/15/2019, in Hennepin County, Minnesota, SKYLAR EDMOND LABARGE, acting alone or by aiding and abetting another, caused the death of victim, a human being, with intent to effect the death of that person or another, but without premeditation.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

That on November 16, 2019, officers were dispatched to 5716 Elliot Avenue South in Minneapolis on a report of a missing person. Upon arrival, officers spoke with an identified adult female. The female reported she is the mother of an identified adult male, hereafter victim. The female reported victim has not been reachable for several days, has missed work, and was not responding via cell phone. During subsequent investigation, officers learned victim was last seen on November 14, 2019, at a bar in Bloomington, Minnesota. Officers also learned victim had been communicating with, and was dropped off at, the residence of ISABELLE CARRIE BRAVEHEART.

Officers spoke with witnesses, including BRAVEHEART, and learned that on November 15, 2019, victim was lured to a residence located at 1563 East 87th Street in Bloomington, Hennepin County, Minnesota. Victim was lured to this residence by PRESTON SCOTT SHARLOW, using the phone of, and pretending to be, BRAVEHEART. Witnesses reported once there, victim was confronted by SHARLOW and SKYLAR EDMOND LABARGE, hereafter defendant. Witnesses reported victim was assaulted by defendant and SHARLOW and went missing thereafter. Officers confirmed both defendant and SHARLOW had connections to this residence. Officers obtained a search warrant for this residence and multiple areas of a blood like substance were detected in the residence and garage. In addition, the residence smelled strongly of recent application of cleaning agents. Victim's cell phone was also located within the residence.

On November 21, 2019, officers located and arrested defendant and SHARLOW. Officers first interviewed SHARLOW. SHARLOW admitted that victim arrived at the above-listed residence in Bloomington. SHARLOW admitted that he and defendant began assaulting victim in the garage. SHARLOW admitted he and defendant repeatedly stomped and kicked victim. SHARLOW admitted victim was brought downstairs into the shower to "clean him up" before being brought back to the garage. SHARLOW admitted that when victim was brought back into the garage, defendant attempted to cut victim's neck with a piece of glass and then forcibly stepped on victim's neck. SHARLOW reported he observed victim's ability to breathe was compromised at this point. SHARLOW admitted he and defendant transported victim's body via vehicle to a remote location in Woodbury, Minnesota, where the body was discarded. SHARLOW agreed to accompany officers and point out the location of the body.

Officers located and recovered victim's body. Victim's body exhibited signs of multiple blunt force injury, mainly to the head and face. Victim's body was transported to the Ramsey County Medical Examiner's Office where an autopsy was conducted. The examination is pending.

Officers then spoke with defendant. Initially, defendant denied any involvement. Defendant eventually admitted he participated in the assault, murder, and transportation of victim's body. Specifically, defendant admitted to kicking and punching victim, helping clean up the evidence, assisting with disposal of the body, and taking victim's neck chain and phone.

At present, defendant and SHARLOW are in custody.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
