The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-3rd Degree-Substantial Bodily Harm**

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 10/21/2019

Control #(ICR#): 19308565

Charge Description: That on or about 10/21/2019, in Minneapolis, Hennepin County, Minnesota, DWIGHT PIERRE LEWIS assaulted Victim and inflicted substantial bodily harm.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 11, 2019, a known adult male, Victim, went to the Minneapolis Police Department and reported that he was punched in the mouth by a man outside the Target Center after the campaign rally for President Donald Trump on October 10, 2019, in Minneapolis, Hennepin County, Minnesota. Victim said he received multiple stitches as treatment for his injuries from the assault. Police confirmed that the assault was captured on video by a news outlet and posted online. Police used that video and other available news-outlet video of the event to identify the assailant as DWIGHT PIERRE LEWIS, Defendant.

On October 21, 2019, Defendant voluntarily surrendered to police. In a post-Miranda interview, Defendant admitted that he was the person in the video who punched Victim.

Defendant is currently in custody.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
