The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about October 18, 2019, at approximately 2:30 a.m., officers responded to a call of a vehicle running over multiple people outside of the Rouge nightclub, located on North Second Avenue between Fifth Street and Fourth Street in Minneapolis, Hennepin County, Minnesota.

There, officers encountered J.S. (Victim 1) J.M. (Victim 2), G.M. (Victim 3), and R.S. (Victim 4). Victim 1 was lying face down in the street, had blood coming from his ears, and had labored breathing. He was non-responsive. Doctors later informed officers that Victim 1 was in critical condition with severe brain injuries and unlikely to survive.

Victim 2 was on the ground an unable to answer basic questions. Victim 3 had blood coming from the back of his head and was complaining of leg pain. Victim 4's face was covered in blood and he was too confused to tell officers what happened. All four victims went to the hospital via ambulance.

Officers spoke with several eye-witnesses, who reported that a man later identified as Defendant EDUARDO MORALES (11/22/1995) and his friend, Witness R.G., had gotten into a fight with others from the nightclub outside on the street. After the fight was broken up, Defendant said to R.G. "give me your keys," and got into the driver's seat of R.G.'s white Mercedes. R.G. sat in the passenger seat.

Defendant initially drove away from the scene of the fight, toward the intersection of North Second Avenue and Fourth Street. Then, Defendant suddenly reversed the vehicle, running over four people. One witness estimated Defendant was driving 50-60 miles per hour. After running over the victims, Defendant continued in reverse toward the intersection of North Second Avenue and Fifth Street. Then, Defendant drove forward, again running over at least two of the victims that were still lying on the ground.

At approximately 3:10 a.m., Defendant turned himself in to the Minneapolis Fifth Precinct. In a post-Miranda interview, Defendant stated that R.G. is a promoter and that the argument with J.S. had started because J.S., who worked for the Rouge, had refused to pay R.G. for his services. Defendant admitted to driving the vehicle and striking the victims, but essentially claimed it was self-defense.

Officers located the vehicle used in the assault at R.G.'s house. It had severe damage to the rear bumper, rear windshield, and driver's side mirror. There was glass all over the backseat, as well as a mark on the driver's side door. Officers interviewed R.G., who gave a statement similar to Defendant's.

Defendant is in custody. Victim 1 remains in critical condition and is unlikely to have full brain functionality again, if he survives.
