The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### COUNTI

Charge: Criminal Sex Conduct-2nd Degree-Victim Under 13-Actor > 36m Old

Minnesota Statute: 609.343.1(a), with reference to: 609.101.2, 609.343.2(a), 609.3455.10

Maximum Sentence: 25 YEARS AND/OR \$10,500-\$35,000

Charge Description: That between January 1, 2018 and May 31, 2019, in Hennepin County, Minnesota, MUSTAFA SHARIEF SHABAZZ, born 09/16/1976, engaged in sexual contact with VICTIM 1, a person under the age of thirteen years, and more than thirty-six months younger than MUSTAFA SHARIEF SHABAZZ.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

In February 2020, law enforcement in Shakopee and Eden Prairie began an investigation into allegations of inappropriate conduct by a wrestling coach identified as MUSTAFA SHARIEF SHABAZZ, Defendant herein, and adolescent female athletes whom Defendant coached.

One girl, hereafter "Victim 1," whose birthday is in October 2008, began wrestling with Defendant in early 2018. In the spring of 2019, Victim 1 refused to return to wrestling after recovering from an injury. Several months later, Victim 1 disclosed to a friend and then to her parents that Defendant had touched her inappropriately while coaching her.

Victim 1 was forensically interviewed at CornerHouse. Victim 1 disclosed that Defendant would touch her genitals over her clothes with his hand while demonstrating wrestling "moves." Victim 1 said that Defendant claimed it was an accident, but he continued to touch her genitals during wrestling practice on numerous occasions. Practices were held in Eden Prairie, Hennepin County, Minnesota.

In the summer of 2019, another adolescent girl, hereafter "Victim 2," reported conduct by Defendant during wrestling events throughout the state that made her uncomfortable. She described long, tight hugs and Defendant "caressing" her back. Defendant was confronted with the allegations in 2019 by an administrator of the wrestling program, and Defendant responded by saying "that kind of thing had happened before." Defendant resigned from the program. Victim 2 later disclosed that Defendant touched her genital area over her clothing on one or two occasions at wrestling tournaments and told her that if she said anything no one would believe her. Investigation also revealed extensive phone and social media contact between Defendant and Victim 2. The sexual contact reported by Victim 2 did not occur in Hennepin County.

Investigators also learned that, in 2013, Defendant was dismissed from a previous job working with children for having inappropriate contact with a fourteen-year-old girl, including meeting her at a motel room.

Defendant's date of birth is September 16, 1976. Defendant is approximately thirty-two years older than Victim 1.

Defendant is not in custody.

The State will seek an aggravated sentence in this case based upon Defendant's position of authority over Victim 1.

#### SIGNATURES AND APPROVALS

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
