The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-1st Deg-Dwelling-Occupied-Non-Accomplice Present

Minnesota Statute: 609.582.1(a), with reference to: 609.582.1, 609.582.1a

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 02/24/2018

Control #(ICR#): 18060418

Charge Description: That on or about and between February 24, 2018 and February 25, 2018, in Hennepin County, Minnesota, Jory Daniel Wiebrand, either directly or as an accomplice, entered a dwelling, without consent and with intent to commit a crime or committed a crime while in the dwelling and another person, Victim, who was not an accomplice, was in the dwelling at any time while Jory Daniel Wiebrand was in the dwelling.

Minimum Sentence: 6 MONTHS

COUNT II

Charge: Criminal Sexual Predatory Conduct

Minnesota Statute: 609.3453.1, with reference to: 609.101.2, 609.3453.2(a)(1), 609.3453.2(b),

609.3455.7, 609.3455.10, 609.3455.6

Maximum Sentence: 20 YEARS + 25%, AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 02/24/2018

Charge Description: That on or about and between February 24, 2018 and February 25, 2018, in Hennepin County, Minnesota, Jory Daniel Wiebrand committed the predatory crime of first-degree burglary in violation of Minn. Stat. 609.582 that was motivated by Jory Daniel Wiebrand's sexual impulses

or was part of a predatory pattern of behavior that had criminal sexual conduct as its goal.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On February 25, 2018, Minneapolis Police officers were dispatched to an apartment complex located on the 500 block of 14th Avenue SE in Minneapolis, Hennepin County, Minnesota on the report of a burglary. Officers responded and spoke with a known adult female, Victim herein. Victim reported that her wallet and keys had been stolen from the residence she spent the night at that evening. Victim stated that she left her wallet, keys, and jacket near the entry to the apartment after she arrived between 8 and 10 p.m. She found her wallet and keys missing at 6:00 a.m. when she woke up. Victim was unsure if the apartment door was locked that evening as she and her friends slept.

In April 2020 as part of an ongoing investigation into a string of sexual assaults, assaults and burglaries occurring in this same neighborhood, officers executed a search warrant at the home of JORY DANIEL WIEBRAND, DEFENDANT herein. In Defendant's bedroom, officers located the wallet and keys belonging to Victim. Officers also found additional identification cards and wallets belonging to some of Defendant's other victims of sexual assault, assault, and burglary.

Later in the day on February 25, Defendant assaulted a known adult female in the backyard of her residence located on the 800 block of 20th Avenue NE in Minneapolis. Defendant approached this victim from behind and put his hands over her mouth forcing her to the ground. Defendant pulled down this victim's pants and penetrated her with his fingers. He also reached under her shirt and ripped her bra. When he pulled down his own pants, this victim was able to break free and flee. Defendant was identified in this attack by DNA evidence.

Additionally, Defendant was identified through DNA evidence in a string of sexual assaults, assaults, and burglaries in this same Minneapolis neighborhood occurring between 2015 and 2020. These crimes bear a marked similarity in pattern of attack. These crimes include but are not limited to:

On March 23, 2015, Defendant assaulted a known adult female in a parking lot located on the 1300 block of 8th Street SE in Minneapolis. Defendant approached this victim from behind as she cleared snow from her vehicle. Defendant sprayed this victim in the face with pepper spray and threw her to ground. Defendant attempted to remove her jacket but was unable. Defendant held this victim to the ground and penetrated her with his fingers and penis before she was able to break free and flee.

On August 4, 2018, Defendant assaulted a known adult female on the porch of her residence located on the 800 block of 6th Street SE in Minneapolis. Defendant approached this victim from behind placing his hands on her mouth and neck. Defendant forced this victim into her residence. Defendant grabbed this victim's breasts and penetrated her with his fingers. When he pulled down his own pants, the victim fought back. Defendant sprayed her in the face with pepper spray and then fled the residence.

On February 8, 2019, Defendant assaulted a known adult female as she walked from her residence to a bus stop in the area of the 600 block of 8th Street SE in Minneapolis. Defendant approached this victim from behind and put his hands over her mouth as she screamed. Defendant dragged this victim to a nearby wooded area and threw her to the ground. He then grabbed this victim on her crotch over her clothing. Defendant fled when a neighbor came outside.

On August 7, 2019, Defendant assaulted a known adult female in her residence located on the 700 block of 4th Street SE in Minneapolis. Defendant blitz attached this victim from behind as she entered her

bedroom. Defendant put his hands over this victim's mouth and across her neck throwing her onto her bed. Defendant penetrated this victim with his fingers. When she fought back, Defendant sprayed her in the face with pepper spray and fled.

Additional crimes of this nature were committed by Defendant on June 2, 2019, July 18, 2019, July 21, 2019, September 12, 2019, January 3, 2020, February 18, 2020 and March 1, 2020.

Defendant is presently in custody on separate charges. A warrant is requested so that additional bail may be set on this case.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
