The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Harassment - Aggravated Violations - Commit Because of Bias

Minnesota Statute: 609.749.3(a)(1), with reference to: 609.749.3(a)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Charge Description: That on or about January 3, 2020, in Hennepin County, Minnesota, JORY DANIEL WIEBRAND harassed victims by following, monitoring, or pursuing the victims, whether in person or through any available technological or other means. and committed the offense because of the victims' or another's actual or perceived race, color, religion, sex, sexual orientation, disability, age or national origin.

Charge: Interfere with privacy-Enter home/Stare/Peep in window

Charge Description: That on or about January 3, 2020, in Hennepin County, Minnesota JORY DANIEL WIEBRAND entered upon property not his own and surreptitiously gazed, stared, or peeped in the window or other aperture of the victims' house or place of dwelling with intent to intrude upon or interfere with the privacy of a member of the household.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On January 3, 2020, Minneapolis Police officers were dispatched to a residence located on the 900 block of 7th Street S.E. in Minneapolis, Hennepin County, Minnesota, on the report of a prowler who was looking in the windows of several residences. These residences are townhomes near the University campus that typically rent to students. Responding officers checked the area but were unable to find the prowler that evening.

In the following weeks, a student and her parent contacted the University of Minnesota Police Department and reported that she had surveillance video of the prowler who was looking in windows on January 3, 2020. This video was presented to law enforcement. The video depicts a white male walking up to the townhouse with a flashlight, approaching the windows, and looking inside. The video captures a clear image of the prowler's face. The prowler was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein, who has been identified as the perpetrator in at least nine sexual assaults, assaults and burglaries occurring in this same neighborhood between 2015 and 2020.

The residents of the townhomes are all female students in their late teens and early twenties. The victims in the sexual assaults, assaults and burglaries are also females in their late teens and early twenties. The nature of the assaults indicate that Defendant would monitor the victims prior to assaulting them. The victims were pursued by Defendant prior to the attack as they left or returned to their homes. Several of these attacks are charged out separately and occurred on March 23, 2015, February 25, 2018, August 4, 2018, June 6, 2019, and August 7, 2019. Additional charges against Defendant are forthcoming.

Defendant is presently in custody on separate charges. A warrant is requested so that additional bail can be set on this case.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
