The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Aggravated Robbery-1st Degree

Minnesota Statute: 609.245.1, with reference to: 609.245.1, 609.11.5(a), 609.05.1, 609.05.2

Maximum Sentence: Offense Level: Felony

Offense Date (on or about): 06/09/2019

Control #(ICR#): 19165487

Charge Description: That on or about 6/9/2019, in Minneapoils, Hennepin County, Minnesota, Jered Andrew Ohsman, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another, took personal property from the person or in the presence of D.J.S, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against D.J.S. to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, while using a firearm.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about June 9, 2019, at approximately 5:00 a.m., Minneapolis police officers were dispatched to a report of a robbery that had occurred in the area of 8th Avenue Southeast and 4th Street Southeast in Minneapolis, Hennepin County, Minnesota. When officers arrived, they spoke with the reporting party and victim, D.J.S. (herein Victim), an adult male.

Victim reported that he was returning from a friend's house at approximately 4:15 a.m. and parked his vehicle, Minnesota license plate 499XRA, in the above-noted area. While he was walking from his vehicle to his apartment complex across the street, he noticed two males standing along a north wall near Maxwell's Café. When he got to the rear entrance of his apartment building, Victim heard footsteps coming up behind him. Victim turned around and saw the two males he had seen earlier approaching him. One of the males pointed a gun at Victim's head and stated, "Drop your keys, phone and empty your pockets or I'll shoot you dead in the head." Victim emptied his pockets as directed on the ground and the other male who was not holding the gun, picked up the items Victim had dropped on the ground, got inside Victim's vehicle using the keys that Victim had dropped and then drove to where the suspect who was holding the gun was standing and picked him up. Both males drove off northbound in Victim's vehicle. Victim then walked to the I-35 highway exit and asked to use someone's phone when they were parked at the stoplight to call 911. Victim stated that he had \$400 cash in the vehicle, as well as Oakley sunglasses. Victim stated that the suspects also took his car and apartment keys, his wallet, and his cell phone, which was worth approximately \$550.

Victim described the males as 18-24 years old, both weighing approximately 150-160 pounds and both approximately six feet tall. Victim stated that male with the gun was a white male with long black hair that went past his shoulders and he had a blue bandana over his face. Victim described the other male as white with a medium build and curly blond hair with a red bandana over his face.

Later that day, Victim was contacted by someone in the area of 45th Avenue and 45th Street South, in Minneapolis, who stated they found his Frisbee golf, which had his name and phone number on it, in their yard. Victim went to the area and looked around for his vehicle. Victim spotted his vehicle parked on the street at approximately 1:00 p.m., but two or three males got inside his vehicle and drove away. Victim described the males as white and noted one of them had black hair that went down to his lower back. Victim stated he recognized the male with the long hair as one of the two males who had robbed him earlier that morning. Victim called 911 at that point but was advised to not follow his vehicle. Victim returned to the same area later that evening and again observed his vehicle parked on the street. Victim called 911 again and officers responded to the area. The vehicle was towed to the impound lot, as Victim did not have his car keys on him.

On June 11, 2019, a homicide investigation began after a male was shot by two males in Minneapolis. The suspect descriptions in that case were a 16-17 year old white male with sandy blonde hair and a 15-16 year old Native American male with long black hair past his shoulders. Given the similar descriptions in both cases, officers believed both cases involved the same suspects. Two male suspects were arrested in connection with the homicide case and later identified as Defendant herein, JERED ANDREW OHSMAN (DOB 8/26/2002) and Co-Respondent H.B. (DOB 6/19/2003).

In a post-Miranda statement, Defendant admitted to committing the robbery in this case with Co-Respondent H.B. Defendant stated that he and Co-Respondent H.B. had stolen another vehicle at gunpoint

earlier that evening but then that car started to run out of gas so they parked in the area of 4th Street Southeast and 8th Avenue Southeast. Defendant stated he and Co-Respondent H.B. were standing by a business in the area when they saw Victim park his vehicle and walk to his apartment complex. They decided to rob Victim and followed him. Defendant stated Co-Respondent H.B. had the gun and demanded Victim's car keys, wallet and cell phone. Defendant collected Victim's items from the ground, used the car keys to open Victim's car and then drove to where Co-Respondent H.B. was standing and picked him up. Defendant identified a photograph of Victim as the person they robbed that night and in that area.

Defendant is in custody.

ON JANUARY 07, 2020, DEFENDANT WAS ORDERED TO STAND TRIAL AS AN ADULT AFTER PROCEEDINGS IN FRONT OF THE HONORABLE JUDGE HOYOS.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
