The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 07/08/2020

Control #(ICR#): 20008600

Charge Description: That on or about 7/8/2020, in Maple Grove, Hennepin County, Minnesota, DAVID RICHMOND EKERS, caused the death of Victim 3, a human being, with intent to effect the death of that person or another, but without premeditation.

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Maximum Sentence: 40 YEARS

Charge Description: That on or between 7/8/2020 and 7/22/2020, in Maple Grove, Hennepin County, Minnesota, DAVID RICHMOND EKERS, caused the death of Victim 2, a human being, with intent to effect the death of that person or another, but without premeditation.

STATEMENT OF PROBABLE CAUSE

THE CASE IS BEING AMENDED TO UPDATE COUNT 2 AND 3 BASED ON THE STATUS OF VICTIMS 1 AND 2 WHO HAVE NOW PASSED AWAY.

Complainant, a licensed peace officer with the Maple Grove Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On July 8, 2020, Maple Grove Police Officers were dispatched to a known residence located in Maple Grove, Hennepin County, Minnesota, on a familial domestic call. The 911 caller, the father of the family, reported that his son DAVID RICHMOND EKERS, the defendant herein, had seriously assaulted multiple members of the family.

Upon arrival, officers located three seriously injured adult female victims. The victims were identified as Victim 1 (Defendant's mother), Victim 2 (Defendant's sister) and Victim 3 (Defendant's grandmother). Officers immediately noticed that all three victims suffered serious head injuries. The victims were rushed to the hospital.

Officers located the defendant within the home and placed him under arrest. Officers located a wrench near one of the victims.

Officers were able to speak with the defendant's father, J.E., who reported that he had been working in the basement with the defendant, who then went upstairs. J.E. reported that he heard Victim 1 scream something like "David, no." J.E. reported that he rushed upstairs to find the victims on the ground and injured. J.E. located the defendant standing with a wrench in his hand which he then dropped.

The defendant was transported to the police station where he was interviewed Post-Miranda. The defendant admitted that he tried to kill all three victims with a wrench. The defendant stated that he didn't attack his father because he saw his father as an ally. The defendant stated that he grabbed the wrench, put on a glove for a better grip, and then proceeded to attack the victims. The defendant stated that he started by striking Victim 2 five to six times in the head while in the dining room. According to the defendant, he then went to find Victim 3 and struck her around five times. The defendant stated that Victim 1 went downstairs to find his dad and that when she came back up, he hit her five times in the face with the wrench.

The defendant, who has mental health issues, told officers that he wanted to kill the victims because he did not want to be on medication or go back to the hospital. The defendant stated that his mother had thought something was wrong the day before and wanted him to go to the hospital.

The defendant confirmed that his intent was to kill all three victims. The defendant stated that he started to plan to kill them one hour before the attack.

Upon evaluation at the hospital, Victim 3 was found to have extensive blunt force injuries to her head. She was found to have multiple skull fractures and multiple intracranial bleeds. Neurosurgery deemed her injuries non-survivable. Family elected to compassionately extubate for comfort care at 0130hrs on July 9th and she was pronounced deceased at 0146hrs.

VICTIM 1 DIED ON JULY 29, 2020 AS A RESULT OF THE INJURIES SUFFERED. VICTIM 2 DIED ON JULY 22, 2020, AS A RESULT OF HER INJURIES.

The defendant is currently in custody.

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
