The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon-Substantial Bodily Harm

Minnesota Statute: 609.222.2, with reference to: 609.222.2, 609.11.4, 609.101.2

Maximum Sentence: 10 YEARS AND/OR \$6,000-\$20,000

Offense Level: Felony

Offense Date (on or about): 08/26/2020

Control #(ICR#): 20222791

Charge Description: That on or about 8/26/2020, in Hennepin County, Minnesota, BRAYSHAUN LAMAR GIBSON assaulted Victim and inflicted substantial bodily harm, while using a dangerous weapon.

Minimum Sentence: 1 YEAR AND 1 DAY

Charge: Assault-3rd Degree-Substantial Bodily Harm

Charge Description: That on or about 8/26/2020, in Hennepin County, Minnesota, BRAYSHAUN LAMAR GIBSON assembled with two or more other persons, disturbed the public peace by intentionally acting with unlawful force or violence to Victim, and BRAYSHAUN LAMAR GIBSON was armed with a dangerous weapon.

COUNT IV

Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 08/26/2020

Charge Description: That on or about 8/26/2020, in Hennepin County, Minnesota, BRAYSHAUN LAMAR GIBSON, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about August 26, 2020, a Minneapolis police sergeant, Victim herein, was walking to his squad car which was parked on 600 block of Nicollet Mall in Minneapolis, Hennepin County, Minnesota. As Victim was getting into his squad car, an adult male, later identified as BRAYSHAUN LAMAR GIBSON, DOB 7/30/1992, Defendant herein, threw a metal garbage can lid at Victim and struck him in the head. Victim fell to the ground and was rendered unconscious, as he had suffered a head injury. Victim was transported to the hospital, where he was treated for possible spinal damage. The metal lid was recovered, and the approximate weight of the object is fifteen pounds.

Surveillance video from downtown cameras captured the assault, and also revealed Defendant's movements that night. Defendant is shown arriving with a group of adult males. After the assault, the video depicts Defendant fleeing from the scene, and later puts on a black jacket before entering a department store on Nicollet Mall through a broken window. Additional video shows Defendant and his companions taking property from the store. The video shows Defendant then enter a vehicle that was parked near 6th Street and 1st Avenue. The vehicle was identified as being involved in a previous but recent burglary, where the Victim in that case reported a connection to Defendant.

Officers were able to identify and apprehend Defendant, who admitted the vehicle was his, and that he was driving the vehicle in downtown Minneapolis the night of the offense. He stated he went downtown to eat dinner. After receiving the appropriate constitutional warnings, Defendant admitted he became enraged over misinformation about officers shooting someone downtown, only to later learn that it was a suicide. He stated he regretted being downtown and getting involved in the "chaos" and acknowledged he now had to face the consequences.

A search warrant was executed on Defendant's vehicle and officers recovered clothing with security tags consistent with what is sold and used in the department store Defendant went in the night of the assault. A search warrant was also done on Defendant's cell phone, and officers recovered multiple photographs of Defendant wearing what appeared to be the same clothing he was wearing during the offense.

Victim has since been released from the hospital but continues to receive therapy and ongoing treatment for his injuries.

Defendant is currently in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
