The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sex Cond-4th Degree-Victim Mental Impair/Helpless**

Minnesota Statute: 609.345.1(d), with reference to: 609.345.2, 609.101.2, 609.3455.10

Maximum Sentence: 10 YEARS AND/OR \$6,000-\$20,000 PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 06/27/2020

Charge Description: That on or about 6/27/2020, in Hennepin County, Minnesota, Jonathan Maurice-Robertson Taylor, engaged in sexual contact with the victim, knowing or having reason to know that the victim was physically helpless.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On 27 June 2020, Minneapolis Park Police Department Officers responded to the area near Powderhorn Park, Minneapolis, Hennepin County, Minnesota for a reported assault. Upon arrival, officers spoke with a known adult female, Victim herein, who reported she had been assaulted by her boyfriend, JONATHAN MAURICE-ROBERTSON TAYLOR, Defendant herein.

Victim stated she fell asleep alone in her tent. She awoke to Defendant's hand under her shirt, groping her breast. Victim pushed Defendant away and turned to face him when she realized Defendant had taken her knife and was pointing it at her, just staring at her. Victim screamed and ran out of the tent. Defendant was found a short distance away with Victim's knife still in his pocket.

Officers confirmed there is a Domestic Assault No Contact Order prohibiting Defendant from being near or contacting Victim. Officers also confirmed there was a felony warrant for Defendant's arrest after failing to appear at his court date the previous week.

Your Complainant is aware Defendant is currently charged with sexually assaulting Victim in case #27CR2012403.

Your Complainant is aware Defendant is in custody.
