The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sex Conduct-1st Degree-Penetration-Victim 13-15 - Position of Authority

Minnesota Statute: 609.342.1(b), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 12/28/2020

Control #(ICR#): 20320310

Charge Description: That on or about 12/28/2020, in Minneapolis, Hennepin County, Minnesota, DECOREY LAMAR BOZEMAN, born 01/02/1992 who was in a current or recent position of authority over Victim, engaged in sexual penetration with the victim, a person between the ages of thirteen and sixteen years at the time, and DECOREY LAMAR BOZEMAN is more than forty-eight months older than the victim.

STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the Minneapolis Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On December 28, 2020, Minneapolis Police Officers were dispatched to a known residence located in Minneapolis, Hennepin County, Minnesota, on a sexual assault call. Upon arrival, officers met with the juvenile victim, a 13-year-old male, hereinafter referred to as Victim. Victim reported that he was at the apartment of his dance teacher, DECOREY LAMAR BOZEMAN, (date of birth 1/2/92) the defendant herein, where he spent the night. Without going into detail, Victim reported that he had been sexually assaulted by the defendant.

Victim went to the hospital for a sexual assault exam. During the examination, Victim described the sexual assault. Victim reported that the defendant penetrated Victim's anus with his penis and engaged in anal sex until ejaculation.

The defendant was interviewed post-Miranda. The defendant stated that he is Victim's dance teacher and that he picked up Victim from the dance studio on the 27th and had Victim spend the night at his apartment in Minneapolis. The defendant admitted that on the 28th, he engaged in sexual penetration of Victim by putting his penis into Victim's anus.

The defendant is currently in custody.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
