Lub sij hawm thaum nws raug tua, Mr Vue yeej nqa thiab tua rab phom ntev uas tua tau tas mus li tuaj rau tub ceev xwm. Ua ntej thaum ntawv nws twb tau siv rab phom los hem nws tsev neeg.

Cov tub ceev xwm tua phom rov qab yam tiv thaiv lawv tus kheej thiab lwm cov tub ceev xwm, ua tus yam ntxwv vim txoj kev ntshai thiab txhawj xeeb tsam lawv raug mob los raug tuag. Yeeb vim qhov xwm txheem no, Lawv txoj kev siv kom txov tau neeg txoj sia mas yeej tsim nyog lawm yeeb vim txoj kev hawv thiab kev pom mas yeej tsim nyog lawm.

Thaum 3:07 a.m. lub 12 hlis hnub tim 15, 2019, Chiasher Vue tus tub uas muaj hnub nyooog lawm tau hu 911 thiab tau hais tias nws txiv qaug cawv heev thiab pheej tua phom hauv lawv lub tsev ntawm 3114 Thomas Avenue North, Minneapolis, Hennepin County. Tus tub hais tias nws txiv “nyuam qhuav nyem phom nrov,” tua peb los yog plaub phom, es nws thiab nws cov kwv tij thiab muam ntshai heev. Tus tub kuj hais tias muaj lwm cov neeg uas yog lawv tsev neeg nyob nraum zoo hauv ib lub tsheb tab sis nws mus coj tsis tau nws pog “Mr Vue niam yog tus neeg zaum hauv laub lawm xwb” tawm ntawm lub tsev mus. Tus neeg teb xov tooj rau tub ceev xwm tau qhia kom tus tub tsav tsheb mus rau ntawm txoj kev Lowry thiab Thomas Avenues es mus ntsib cov tub ceev xwm ntawm Minneapolis Police Department (MPD) tov.

Cov tub ceev xwm thiaj li thov kom muaj ib tug kws sib khom (negotiator) tuaj rau ntawv thiab kom lub tsheb thauj neeg mob tuaj nres ntawm Lowry thiab Xerxes Avenues, nyob deb li ntawm tsib nplauv ntawm lub tsev. Mr. Vue tus ntxhais hu Mr. Vue lub xov tooj thiab tus tub ceev xwm hmoob kuj nrog Mr. Vue tham thiab.

Mr. Vue qhia rau tub ceev xwm hais tias nws mam li los ntawm lub qhov rooj yam tsa nws ob sab tes. Tab sis, nws tuaj txog ntawm lub qhov rooj ces cia li rov qab mus hauv tsev lawm. Nws rov qab tuaj txog ntawm lub qhov rooj li ib ob feeb tom qab tuav rab phom ntev yam twb lub hau phom rau hauv av. Nws tsa lub hau phom mus ncaj rau ntawm cov tub ceev xwm. Cuaj tug tub ceev xwm thiaj li nyem phom, thiab Mr. Vue kuj nyem phom thaum lub tsam thawj ntawv. Cuab tsis tim seb leej twg yog tus tua thawj phom. Mr. Vue ntog rau hauv pem teb thiab rov qab sawv es tsa nws rab phom zaum ob. Thiaj li muaj phom nrov ntxiv. Mr. Vue rov qab ntog dua ces lub suab phom thiaj li ntsiag lawm.

## **COV TUB CEEV XWM ZAJ TXOG QHOV XWM TXHEEJ**

- **Sergeant Troy Carlson**

Minneapolis Police Sergeant Troy Carlson yeej tau ua hauj lwm rau Minneapolis Police Department rau 16 xyoo thaum qhov xwm txheej no tshwm sim. Nws yog tus thawj tswj Fourth Precinct Patrol Supervisor uas yog ua hauj lwm rau yav hmo ntuj thiab yeej kawm tiav hlo cov txheej txheem hauv SWAT. Cov ntaub ntawv txog tus neeg thiab kev kawm yeej tau mus nqa uas yog ib famt ntawm txoj kev tshawb fawb qhia tau hais tias Sergeant Carlson yeej tau mus kawm tsim nyog thiab yog ib tug tub ceev xwm uas meej pem. Sergeant Carlson nyob rau hauv

nws lub hoop kas ntawm Fourth Precinct uas nws yog ib tug Lieutenant thaum nws hnov cov neeg teb xov tooj hais tias tus neeg hu 911 tau tawm ntawm nws lub tsev vim nws txiv pheej tua phom hauv tsev.

Sergeant Carlson tau hu xov tooj thiab hais kom cov neeg hu tawm tuaj mus ntsib cov tub ceev xwm. Carlson paub tau hais tias muaj ib tug txiv neej muaj 50 mus rau 60 xyoo nyob rau hauv lub tsev. Nws tau mus rau ntawm txoj kev Thomas thiab Lowry es mus nrog cov tub ceev xwm thiab tsev neeg tham es paub tau hais tias rab phom yeej tau tua nrov tom qab tsev neeg tawm ntawm lub tsev mus. Nws kuj paub tau hais tias muaj peb rab phom ntev ntev uas nyob hauv tsev thiab muaj ib tug pog uas muaj 70 xyoo tseem nyob hauv tsev. Sergeant Carlson thiaj li hu rau tus The Watch Commander kom xa ib tug kws sib khom tuaj rau ntawm qhov chaw. Tus Watch Commander thiaj li pib ua txoj hauj lwm ntawv. Nws kuj teem ib lub tsheb thauj mob tuaj nres faj seeb tseg rau ntawm qhov chaw ntawv tsam muaj cov pej xeem los yog tub ceev xwm raug mob.

Sergeant Carlson qhia Officers Peng Moua thiab Ty Yang, uas hais lus hmoob, uas siv qhov qhia pej xeem qhov chaw nyob thiab mus cuag tus txiv neej hauv lub tsev, uas muaj npe hu ua Mr. Chiasher Fong Vue. Officer Moua thiaj nrog Mr. Vue tham yam siv lub xov tooj ntawm tes thiab qhia kom Mr. Vue tawm tuaj ntawm nws lub tsev yam tsa nws ob sab tes.

Sergeant Carlson kuj muaj kev txhawj xeeb txog qhov teeb meem no vim nws pau hais tias muaj phom nyob rau hauv tsev thiab txhua yam tshwm sim ceev heev. Seargent Carlson kuj paub tau hais tias hom teeb meem zoo li no kuj yuav loj hlob ceev heev thiab nws kuj txhawj txog ntawm cov tub ceev xwm uas yuav mus rau hauv lub tsev, nrog rau txoj kev nyab xeeb ntawm cov pej xeem uas tej zaum yuav muaj kev phom sij yog hais tias Mr. Vue nqa rab phom tawm ntawm lub tsev tuaj. Yuav luag tib lub sij hawm thaum Officer Moua hais tias Mr. Vue yuav tawm tuaj, Mr. Vue tshwm plaws ntawm lub qhov rooj. Officer Moua thiab Yaj nkawv thiaj li mus ncaj ntawm nws thiab qw ua lus hmoob.

Mr. Vue cia li rov qab nkag kiag ceev ceev hauv tsev. Seargent Carlson npaj ua ntej tsuas kom Officer Moua thiab Yaj sib txuas lus nrog Mr. Vue thiab kom Mr. Vue tawm tuaj rau ntawm txoj kev taug thiab kom nws txhos caug. Nws muaj kev txhawj xeeb heev txog txoj kev nyab xeeb ntawm tus pog uas tseem nyob hauv tsev. Ib sij huaj xwb nws hnov cov tub ceev xwm qw, “Nws muaj phom! Nws muaj rab phom ntev!” Nws hnov lwm tus tub ceev xwm qw, “Orange Orange Orange!” uas yog cov lus cim hais tias kom tua cov mos txwv uas tsis tshua muaj zog. Nws nyob nram qab ntawm ib lub tsheb uas nres, Seargent Carlson pom Mr. Vue rov qab los ntawm lub qhov rooj iav es siv nws lub xwb pwg los txheem lub qhov rooj kom qhib. Tom qab hnov hais tias muab cov mos txwv uas tsis tshua muaj zog ntsaws tag lawm, Seargent Carlson pom lub hau phom tsa hauv av los taw rau cov tub ceev xwm. Ces nws thiaj li hnov cov suab yaj phom thiab phom ntev nrov. Saib ntawm lub qhov rais mus Seargent Carlson kuj pom zoo li ib tug neeg kuj sawv ntsug ntawv ces nws kuj tua ob phom. Nws hnov lwm cov tub ceev xwm qw thiab hnov hais tias, “Txhob tua phom lawm!” Sergeant Carlson hnov Officer Andrew Reed ntawm nws lub puv hais tias nws yeej pom tus neeg ntawv meej meej lawm thiab nws tsis nti lawm.

Sergeant Carlson thiaj li pib npaj kev mus pab rau qhov xwm txheem phom sij heev thiaj kom Officer Donnell Crayton xa nws tus aub (K9) nrog nws pawg neeg ntawv mus seb puas tseem muaj kev phom sij rau cov tub ceev xwm thiab tus pog laus. Carlson thiab nws pawg neeg thiaj li nkag mus es thiaj li tshem Mr. Vue kom nrug deb ntawm nws rab phom, uas nyob ntawm nws ib sab. Mr. Vue raug tua lawm tab sis nws tseem ua pa; Carlson, lwm cov tub ceev xwm ntawm MPD, thiab cov kws kho mob thiaj li nqa nws mus rau lub tsheb thauj mob uas yeej nres nraum zoo lawm. Kuj muaj ntau tus neeg uas sawv cev rau MPD kuj tuaj txog thiab los tswj cov txheej txheem uas phom sij ntawv.

Sergeant Carlson nws yeej tuaj teev lus rau BCA cov lus tshawb fawb rau thaum lub 12 hlis hnub tim 17, 2019. Nws yeej tsis tau saib daim yeeb yaj kiab ntawm nws lub koob thaij (BWC) ua ntej nws tuaj xam phaj.

### **Officer Donnell Crayton**

Minneapolis Police Officer Donnell Crayton twb tau ua hauj lwm nrog Minneapolis Police Department rau xya xyoo ntau thaum qhov xwm txheej no tshwm sim. Cov ntaub ntawv txog tus neeg thiab kev kawm yeej tau mus nqa uas yog ib faim ntawm txoj kev tshawb fawb qhia tau hais tias Officer Crayton yeej tau mus kawm tsim nyog thiab yog ib tug tub ceev xwm uas meej pem. Officer Crayton raug xaiv los ua hauj lwm rau chav muaj aub (K9) thiab yeej muaj kev lav phib xaub thoob plaws lub nroog hmo ntawv nrog nws tus khub, uas yog tus aub muaj ob xyoo hom German Shepherd hu ua Jett. Officer Crayton nyob rau sab qaum teb hnub tuaj ntawm lub nroog Minneapolis thaum nws hnov tus neeg teb xov tooj tso tawm hais tias muaj teeb meem txog txheeb ze sib ntaus uas tus neeg tsim teeb meem tau tua ob phom hauv tsev. Nws tsav tsheb mus rau qhov chaw ntawv thiab paub thaum mus yuav txog hais tias tsev neeg tau tawm ntawm lub tsev thiab nyob rau ntawm txoj kev Lowry thiab Thomas Avenues nrog tub ceev xwm.

Thaum nws tuaj txog, Officer Crayton mus rau nram qab ntawm lub tsev es pom tau hais tias tus MPD tus tub ceev xwm txawj hais lus hmoob nrog tus neeg nyob hauv lub tsev tham, thiab Mr. Vue twb yuav tawm ntawm lub qhov rooj yam tsis muaj teeb meem. Officer Crayton kuj paub tau hais tias Sergeant Carlson tau thov tus kws sib khom lawm. Officer Crayton rho Jett tawm ntawm lub tsheb es vam thiab cia siab hais tias Jett yuav txwv Mr. Vue kom txhob khiav los yog sib ntaus nrog tub ceev xwm. Officer Crayton thiab Jett khiav ntawm cov nyom mus rau sab pem qhov rooj ntawm lub tsev, thiab tub ceev xwm qhia nws hais tias Mr. Vue tawm tuaj thiab twb rov qab mus hauv tsev lawm.

Lub tsev tub ceev xwm-Minneapolis Police Department tso cai rau tus tub ceev xwm uas siv qhov txov tau neeg txoj sia rov mu saib daim yeeb yaj kiab ntawm qhov xwm txheej ua ntej tuaj teev lus. Lub koos haum BCA, yog lub koos haum tshawb fawb, kom mus saib cov kev cai ntawm cov koos haum ua ntej seb cov tub ceev xwm saib puas tau daim yeeb yaj kiab ua ntej tuaj teev lus.

Officer Crayton thiab Jett mus nkaum nram qab ntawm ib lub tsheb minivan uas twb nres lawm. Sergeant Carlson nyob ntawm Officer Crayton sab laug. Crayton nug seb puas tas muab Jett rov qab tso hauv lub tsheb tsam ib pliag Jett tsem ces ua rau tus neeg tsim kev kub ntxhov ntshai. Sereant Carlson hais tias tsis thus muab tso rau hauv, lwm tus tub ceev xwm twb sim hu rau Mr. Vue thiab twb hais kom nws tawm tuaj thiab cia li nyoo xwb. Officer Crayton pom lub qhov rooj qhib tab sis nyob rau ntawm nws pom thiab vim lub qhov rais ua fws, nws kuj tsis pom tus neeg tab sis pom lub hau phom tawm ntawm qhov rooj yam “mam mam npaj”, txhais tau hais tias muab taw rau hauv av. Officer Crayton thiab lwm cov tub ceev xwm qw, “Phom ntev!” ces lub hau phom ntawm rab phom ntev pib tsa zus. Nws ntshai tsam Mr. Vue tua nws los yog tua lwm cov tub ceev xwm, Officer Crayton thiaj tua nws rab phom. Nws pom tau hais tias Mr. Vue twb tua rov qab tuaj thiab thaij li qw, “Nws tua phom lawm!” Officer Crayton pom tau hais tias rab phom ntev ntawv yuav muaj zog txaus uas nws cov mos txwv yuav tua tshab tub ceev xwm cov tsho khuam yog hais tias tua raug lawv.

Officer Crayton pom Mr. Vue thim rov qab thiab, ntseeg tau hais tias tsis tau raug Mr. Vue, thiaj tau qw, “Ua li nws rov qab lawm!” Officer Crayton ntseeg tau hais tias Mr. Vue rov qab nkag mus nkaum los yog mus ntim mos txwv. Tsis paub saib nws tua puas tsawg phom thiab muaj puas tsawg lub mos txwv seem hauv nws rab phom, Officer Crayton thiaj li rov qab mus ntsaw mos txwv nram qab ntawm lub tsheb minivan. Officer Crayton pom Mr. vue sab ko taw nyob rau pem teb thaum nws ntog lawm ces lwm cov tub ceev xwm hais tias, “Nws vau lawm!”

Officer Crayton thiab Jett, uas yeej muaj hlua khi thiab raug tuav los ntawm Officer Crayton txhua lub sij hawm, mus rau hauv lub tsev nrog rau lwm cov tub ceev xwm thiaj txiav txim tau hais tias Mr. Vue yuav tsis muaj kev phom sij rau lawv los yog lwm leej lwm tus lawm.

Officer Crayton yeej yeem tuaj teev lus rau BCA cov kws tshawb fawb thaum lub 12 hlis hnub tim 18, 2019. Nws thiab nws tus kws li choj twb saib daim yeeb yaj kiab ntawm nws lub BWC ua ntej tuaj xam phaj.

- **Officer Daniel Ledman**

Minneapolis Police Officer Daniel Ledman twb tau ua hauj lwm nrog Minneapolis Police Department rau 13 xyoo thaum qhov xwm txheej uas tshwm sim. Cov ntaub ntawv txog tus neeg thiab kev kawm yeej tau mus nqa uas yog ib fam ntawm txoj kev tshawb fawb qhia tau hais tias Officer Ledman yeej tau mus kawm tsim nyog thiab yog ib tug tub ceev xwm uas meej pem. Officer Ledman ua hauj lwm nrog nws tus khub Officer Jason Wolff. Nkawv nyob ntawm tsev tub ceev xwm Fourth Precinct thaum nkawv hnov los ntawm tus kws teb xov tooj hais tias muaj cov txheeb ze sib ntaus uas tua phom hauv tsev lawm. Lwm cov tub ceev xwm kom cov neeg nyob hauv lub tsev tawm mus es Ledman thiab Wolff mam li ntsib lawv.

Officers Ledman thiab Wolff mus txog ntawm txoj kev Lowry thiab Thomas Avenues ces pom peb tug txiv neej thiab ib tug poj niam los ntsib nkawv. Lwm cov tub ceev xwm kuj

qhia kom cov neeg los ntsib lawv yam siv lub puv los hais. Officer Ledman kom ob tug txiv neej, uas yog ob tug kwv tij, mus zaum hauv nws lub tsheb tub ceev xwm los qhia cov xov tseem ceeb. Tus tij laug hlob hais tias nws txiv qaug cawv heev thiab tau nrog nws sib cam thiab nrog lwm tus kwv tij sib cam. Nws hais tias nws txiv muaj cov phom ntev ntev thiab nws txiv tua phom tom qab nws thiab nws cov kwv tij thiab muam tawm hauv lub tsev mus. Tus kwv tij sab tov tsis tshua kam qhia cov xov ceem tseeb es xav rov qab mus hauv tsev mus nrog nws txiv tham tab sis Officer Ledman qhia nws hais tias yuav tsis nyab xeeb vim muaj kev cuam tshuam nrog rab phom lawm.

Thaum lwm cov tub ceev xwm tuaj txog, Officer Ledman sim qhia seb tsev neeg muaj leej twg thiab tus txiv neej nyob hauv tsev nrog rab phom. Nws paub tau hais tias muaj ib tug pog laus tseem nyob hauv tsev. Muaj tub ceev xwm uas txawj hais lus hmoob tau sib txuas lus nrog Mr. Vue, hauv xov tooj, thiab Officer Ledman to taub hais tias Mr. Vue yuav tawm ntawm nws lub qhov rooj tuaj.

Officer Ledman txav ze zus thiab mus nkaum nram qab ntawm ib tso ntoo uas nyob ob lub tsev rau sab qaum teb 3114 Thomas. Nws pom Mr. Vue los rau ntawm lub qhov rooj, hnov cov tub ceev xwm uas txawj hais lus hmoob nrog Mr. Vue tham, thiab pom Mr. Vue mus rov qab sab hauv lawm. Dhau li ib nas this, ces Mr. Vue rov qab los ntawm qhov rooj, ces lwm tus tub ceev xwm hais tias Mr. Vue muaj rab phom ntev. Nyob nram qab ntawm tso ntoo Officer Ledman kuj pom ua ntej mas ib qho dub dub uas nyob ntawm Mr. Vue ib sab ces nws pom lub hau phom tawm tuaj. Officer Ledman xav hais tias qhov no “Qhov no vwm dhau lawm” vim tus neeg no yeej paub hais tias muaj tub ceev xwm nyob ntawv thiab twb sim sib txuas lus hmoob nrog nws es nws rov qab mus hauv tsev es tawm tuaj rog rab phom. Yeej paub hais tias nws muaj cov khub nyob ntawm ib sab thiab pem qaum tsev, Officer Ledman thiaj pib tua nws rab yaj phom. Nws pom Mr. Vue vau rau hauv pem teb rau hauv lub maum kaum tsev. Officer Ledman txav mus ze zog li ib lub tsev es pom Mr. Vue sawv los zaum. Ntshai tsam Mr. Vue rov qab tua dua yog hais tias nws tsis rov qab tua, Ledman thiaj tua nws rab yam phom ntxiv txog thaum mos txwv tag. Nws rov qab ntim mos txwv rau nws rab phom ces thiaj li txav ze zog mus rau ntawm Officer Yang thiab Wolff. Muaj ib lub sij hawm thaum qhov teeb meem no Officer Ledman ntseeg tau hais tias nws hnov ib tug tub ceev xwm qhia hais tias nws yuav siv cov mos txwv uas tsis tshua muaj zog.

Officer Ledman mus txog ntawm lub tsev thiab Mr. Vue nrog rau lwm cov tub ceev xwm thiab pom rab phom ntev ntawm qhov chaw uas Mr. Vue ntog thiab nws tsis nti lawm. Thaum yuav tawm ntawm lub tsev mus nws pom cov plav tooj mos txwv nyob rau ntawm tus tau ntais ntu yuav nces mus rau xab ob.

Khw yees li ib lub lim tiam ua ntej, Officer Ledman twb tau mus txog ntawm 3114 Thomas vim muaj neeg hu txog kev kub ntxhov los ntawm neeg xiam hlwb rau ib tug hauv tsev neeg uas tsis nyob rau hmo ntawv lub 12 hlis hnub tim 15. Officer Ledman tau ntsib Mr. Vue ib me pliag rau lub sij hawm ntawv thiab muaj kev ntsib nrog tus tub qhia txog qhov xwm txheem rau hnub tim 15 **tshaj**.

Officer Ledman yeej tuaj teev lus rau cov kws tshawb fawb ntawm BCA rau lub 12 hlis hnub tim 19, 2019. Nws tau saib daim yeeb yaj kiab los ntawm lub koob thaij BWC nrog nws tus kws lij choj ua ntej nws tuaj xam pha thiab tau saib ib ntu ntawm daim yeeb yaj kiab ob zaug diam.

Minneapolis Police Officer Peng Moua twb tau ua hauj lwm nrog Minneapolis Police Department rau tsib xyoo ntau thaum qhov xwm txheej uas tshwm sim. Cov ntaub ntawv txog tus neeg thiab kev kawm yeej tau mus nqa uas yog ib faim ntawm txoj kev tshawb fawb qhia tau hais tias Officer Moua yeej tau mus kawm tsim nyog thiab yog ib tug tub ceev xwm uas meej pem.
