#### OBSERVATIONS AND INTERPRETATIONS

This incident occurred on a roadway in a residential area, 77th Street runs east and west in this area with a grassy center median between the eastbound and westbound lanes.

There was a male identified as Brian Quinones-Rosario lying supine in the grass of the center median. He was wearing a black and gray sweatshirt, white shirt, blue jeans, gray underwear and white shoes. The sweatshirt and white shirt appeared to have been cut to expose his chest for lifesaving measures. His eyes were partially open and there was an oral airway in his mouth. There were areas of blood-like substance (BLS) on his face, body, clothing and on the ground around him. His hands were handcuffed behind his back. There were medical bags and medical debris on the ground around him.

There were multiple Edina and Richfield Police vehicles with their emergency lights activated in the eastbound lanes of 77th Street. There was a gray Honda Civic bearing MN 761MWE, facing eastbound on 77th Street, running with its lights on and the driver's door was open. There was a white Chevrolet Traverse bearing MN DCB303 parked behind the squad cars with the driver's door open.

There were cartridge cases marked 'Hornady 45 Auto +P' on the eastbound roadway (Evidence Marker's [EM's 2-9]) and on the center median (EM's 10, 12-14). There was a cartridge case marked 'Luger 9mm FC' on the center median (EM 1). There was a Taser marked X13000HM5 (EM 11) with a fired cartridge on the center median. Wires and two Taser probes (EM 15) were on the center median. A silver-colored knife (EM 16) was on the westbound roadway. A magazine with an unknown number of cartridges (EM 20) was in the Richfield Police squad marked MN SH907, between the driver's seat and the center console.

Dr. Jackson and Investigator Behnke from the Hennepin County Medical Examiner's Office (#19-5446) arrived at approximately 0123 hours. They noted wounds on Quinones-Rosario's chin, chest and abdomen upon their initial observation. There were clear wound dressings on his back and right side. There was a black flashlight (EM 19) on the ground under Quinones-Rosario.

#### PROCESSING RESULTS

Scene photographs were taken by CSI Sjolander and myself.

Separate swabbings were collected from Quinones-Rosario's right and left hands,

The cartridge cases (EM's 1-10, 12-14), Taser (EM 11), Taser probes (EM 15), knife (EM 16), flashlight (EM 19), and magazine (EM 20) were collected for possible further processing.



## OBSERVATIONS AND INTERPRETATION

The following incident occurred on a residential street. I was requested to create a forensic map with a Trimble 7X GPS unit in relation to an on-going Officer Involved Death Investigation. In the process of creating the map, I discovered a deformed copper jacket bullet (Evidence Marker [EM] 1) in the dirt and grass inside the crime scene. The bullet was in the area in close proximity to where the ground markings indicated a victim was laying on the ground. After completing the map and powering down the GPS unit, four cartridge cases, all marked "Luger 9MM FC" (EMs 2-5) were found in the dirt and grass east of the previously mentioned body markings on the ground.

## PROCESSING RESULTS

Photographs were taken to document the scene.

A forensic map was created using the Trimble 7X GPS.

The locations of the five additional items of evidence were added to the forensic map. EM 1, the deformed bullet, was added to the map using the GPS unit, however, the four cartridge cases were added to the map using a triangulation method due to the GPS unit being powered down prior to their discovery.

It could not be determined if Item 65 fired 21 (a deformed bullet). The comparative examinations showed agreement of individual characteristics, but insufficient for an identification. The comparative examinations were inconclusive.

Item 100-1 (a small red-orange colored plastic insert) was not suitable for comparative examinations.

### Results / Interpretations / Opinions:

Examination of Item 44 (a Glock Model 17 Gen 5 9mm Luger caliber pistol bearing serial number BGMP965) showed the safety mechanisms to be functional. Item 44 was test fired five times without malfunction using the magazine from Item 43 and five cartridges from Item 42-2.

Examination of Item 51 (a Glock Model 17 Gen 5 9mm Luger caliber pistol bearing serial number BGMP933) showed the safety mechanisms to be functional. Item 51 was test fired five times without malfunction using the magazine from Item 52 and five cartridges from Item 56-2.

Examination of Item 61 (a Glock Model 21 Gen 4 45 Auto caliber pistol bearing serial number WHN685) showed the safety mechanisms to be functional. Item 61 was test fired five times without malfunction using the magazine from Item 63 and five cartridges from Item 64-2.

Examination of Item 65 (a Glock Model 21 Gen 4 45 Auto caliber pistol bearing serial number VYL636) showed the safety mechanisms to be functional. Item 65 was test fired five times without malfunction using the magazine from Item 67 and five cartridges from Item 68-2.

Examination of Item 69 (a Glock Model 21 Gen 4 45 Auto caliber pistol bearing serial number WHN708) showed the safety mechanisms to be functional. Item 69 was test fired five times using the magazine from Item 70 and five cartridges from Item 71-1. Item 69 failed to feed one cartridge from the magazine into the chamber during the test firing process. Item 69 was test fired an additional five times without malfunction using laboratory ammunition.

Examination of Item 79 (a Glock Model 17 Gen 5 9mm Luger caliber pistol bearing serial number BGMP939) showed the safety mechanisms to be functional. Item 79 was test fired five times without malfunction using the magazine from Item 80 and five cartridges from Item 78-2.

Comparative examinations of Item 1 (a cartridge case bearing headstamp: FC 9MM LUGER) against Item 44-1 (cartridge cases test fired from Item 44) showed the presence of matching features. This means that Item 1 was fired in Item 44.

Comparative examinations of Items 22 through 25 (four cartridge cases bearing headstamp: FC 9MM LUGER) against Item 51-1 (cartridge cases test fired from Item 51) showed the presence of matching features. This means that Items 22 through 25 were fired in Item 51.

Comparative examinations of Items 6 through 9 (four cartridge cases bearing headstamp: HORNADY 45 AUTO+P) against Item 61-1 (cartridge cases and bullets test fired from Item 61) showed the presence of matching features. This means that Items 6 through 9 were fired in Item 61.

Comparative examinations of Items 2 through 4, 10 and 12 through 14 (seven cartridge cases bearing headstamp: HORNADY 45 AUTO+P) against Item 65-1 (cartridge cases and bullets test fired from Item 65) showed the presence of matching features. This means that Items 2 through 4, 10 and 12 through 14 were fired in Item 65.

Comparative examinations of Item 5 (a cartridge case bearing headstamp: HORNADY 45 AUTO+P) against Item 69-1 (cartridge cases and bullets test fired from Item 69) showed the presence of matching features. This means that Item 5 was fired in Item 69.

Items 45, 57, 62, 66 and 76 (cartridges) were not used for test firing.
