OBSERVATIONS AND INTERPRETATIONS

The following incident occurred inside apartment #7 of a multi-level, multi-tenant, apartment complex. The perimeter of the apartment building was secured with crime scene tape in multiple areas.

Lying on his back in the master bedroom was an adult male identified as Matthew Tuhkanen. He was wearing a

dark-colored sweatshirt, a dark-colored shirt, black shorts, grey sweatpants, and multi-colored shoes. The grey sweatpants were wet and there were areas of blood-like substance (BLS) on his sweatshirt and shirt. His eyes and mouth were open and there were areas of BLS on his face. Medical bandages were on his right shoulder and torso. There were areas of BLS and two suspected gunshot wounds on Tuhkanen's torso. Both of his arms were bent at the elbows and Tuhkanen's hands were behind his back. His right leg was straight and his left leg was bent at the knee. There were areas of BLS on the floor, wall, and a blanket near Tuhkanen.

A cartridge case [Evidence Marker (EM) 1], marked "9MM FC LUGER", was near the door frame in the master bedroom. Two cartridge cases (EM 2 and EM 3), marked "9MM FC LUGER", were on the floor near the door. A cartridge case (EM 4), marked "9MM FC LUGER", was in the closet. A plastic toy hammer (EM 5) was on the floor. An open medical bag was on the nightstand. An oxygen tank was on the bed. A hose ran from the oxygen tank to a bag valve mask positioned on the floor in the bedroom. Multiple gloves and medical packaging were scattered in the room. A tablet (EM 10), with a blue case and charger, was on the bed. A cigarette butt (EM 9) was on the floor near Tuhkanen.

A phone (EM 6) and a medication bottle (EM 7), in Matthew Tuhkanen's name, were on the bathroom counter. Another medication bottle (EM 8), in Matthew Tuhkanen's name, was in the bathroom vanity.

Detective Nybeck provided a copy of a search warrant, signed by Judge Regis, to search and process the scene for items of evidence.

Investigator Burkhalter, from the Hennepin County Medical Examiner's Office (19-0460), arrived on scene at approximately 2309 hours. During his initial assessment suspected gunshot wounds were revealed in his right shoulder and right arm. Two suspected bullet holes were revealed in Tuhkanen's sweatshirt and his shirt. Tuhkanen hands were handcuffed behind his back. A black jacket (EM 11), with miscellaneous items inside the pockets, was near Tuhkanen's feet.

A coffee table was on its end in the living room. A book, marked "A Gathering of Spies", was inside of a dresser. A piece of paper, with a white powdery substance, was inside the book.

A further search of the master bedroom was conducted. A metal object with a pink handle (EM 12) was on the bed. A shot shell flashlight (EM 13) was under the bed. A knife (EM 14) was between clothing items on the shelf in the closet. A medication bottle (EM 15), in Matthew Tuhkanen's name, was in the top dresser drawer.

Results / Interpretations / Opinions:

Examination of Item 21 (a Glock Model 17Gen4 9mm Luger caliber pistol bearing serial number YYY931) showed the safety mechanisms to be functional. Item 21 was test fired five times without malfunction using the magazine from Item 17 (a magazine containing fifteen cartridges) and five cartridges from Item 18 (a magazine containing nineteen cartridges).

Comparative examinations of Items 1 through 4 (four cartridge cases) against Item 21-1 (cartridge cases test fired from Item 21) showed the presence of matching features. This means that Items 1 through 4 were fired in Item 21.

Items 16, 19 and 20 (one cartridge and two magazines loaded with nineteen cartridges) were not used to test fire
