The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

Charge: Assault - 4th Degree - Peace Officer - Demonstrable bodily harm Minnesota Statute: 609.2231.1(c)(1), with reference to: 609.101.2, 609.2231.1(c)

Maximum Sentence: 3 YEARS AND/OR \$6,000

Offense Level: Felony

Offense Date (on or about): 05/16/2021

Charge Description: That on or about 5/16/2021, in Hennepin County, Minnesota, CHRISTOPHER SMITH assaulted a peace officer, while that officer was effecting a lawful arrest or executing a duty imposed upon him by law, and inflicted demonstrable bodily harm upon the officer.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 16, 2021, officers responded to a call for service in the area of Hennepin Avenue and 5th Street North, City of Minneapolis, County of Hennepin, State of Minnesota. Officers were attempting to take a male into custody when another male, identified as CHRISTOPHER SMITH, "the Defendant," maced the four to five officers present. Mace was observed dripping off some of the officers. Additionally, officers were coughing and noted to have impaired vision. The Defendant fled from the scene, but he was later apprehended by officers. The Defendant admitted that he had used mace on the officers and that he would do so again in the future.
