The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Manslaughter - 2nd Degree - Commit or Attempt to Commit Violation

Minnesota Statute: 609.205(5), with reference to: 609.205

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 10/31/2020

Charge Description: That on or about 10/31/2020, in Minneapolis, Hennepin County, Minnesota, LEANN SIAH FARKARLUN, caused the death of Victim by committing or attempting to commit a violation of Minn. Stat. 609.378, Neglect or Endangerment of a Child.

STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the Minneapolis Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 31, 2020, Minneapolis Police Officers were dispatched to a known apartment located in Minneapolis, Hennepin County, Minnesota on a baby not breathing call. Upon arrival, officers located a 5-month-old baby, hereinafter referred to as Victim. Medics took Victim to the hospital via ambulance. Victim was pronounced deceased by medical personnel at the hospital.

Officers at the scene spoke to LEANN SIAH FARKARLUN, the defendant herein, who identified herself as the godmother of Victim. The defendant reported that she was caring for Victim while Victim's mother was out of town. The defendant stated that she returned home late at night after going out with friends and chose to sleep in the same bed as Victim. The defendant reported that she got up to use the restroom and realized that Victim's hand was cold. Upon further checking, the defendant observed that Victim's body was lifeless and she had blood coming from her nose. The defendant had her teenage son call 911 and attempt to perform CPR but Victim did not regain consciousness.

During the initial interview with the defendant, she admitted that she consumed alcohol the night before. Officers observed that she appeared to be intoxicated. The defendant was transported for a blood draw, which was collected at approximately 10:50 a.m. The results of the blood test showed the defendant's BAC to be .142.

An autopsy was performed. The medical examiner's preliminary findings did not find any disease or injury that led to Victim's death. The ME further indicated that there is nothing in his findings that is inconsistent with co-sleeping being the cause of death.

Defendant is not in custody.
