COMPLAINT

Order of Detention

Amended

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: Forty years.

Offense Level: Felony

Offense Date (on or about): 02/28/2021

Control #(ICR#): 21041833

Charge Description: That on or about February 28, 2021, in Hennepin County, Minnesota, TYRONE EDWARD MADDOX, caused the death of S.G.A., a human being, with intent to effect the death of that person or another, but without premeditation, while using or possessing a firearm.

COUNT II

Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony

Minnesota Statute: 609.19.2(1), with reference to: 609.19.2(1), 609.11.5(a)

Maximum Sentence: Forty years.

Offense Level: Felony

Offense Date (on or about): 02/28/2021

Control #(ICR#): 21041833

Charge Description: That on or about February 28, 2021, in Hennepin County, Minnesota, TYRONE EDWARD MADDOX, did without intent to effect the death of any person, cause the death of S.G.A., a human being, while committing or attempting to commit the felony offense of Assault in the Second Degree while using or possessing a firearm.

COUNT III

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence: Fifteen years.

Offense Level: Felony

Offense Date (on or about): 02/28/2021

Control #(ICR#): 21041833

Charge Description: That on or about February 28, 2021, in Hennepin County, Minnesota, TYRONE EDWARD MADDOX possessed ammunition or a firearm and TYRONE EDWARD MADDOX has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Assault in the Second Degree on May 15, 2003, for which the sentence or court supervision expired on or after August 1, 1993.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about February 28, 2021, at approximately 6:22 a.m. officers with the Minneapolis Police Department were dispatched to 3214 Logan Avenue North, Minneapolis, Hennepin County, Minnesota on the report of a shooting. Upon arrival, officers observed the adult female victim S.G.A. lying face down on the ground in the middle of the street. The victim was unconscious and not breathing. Officers observed the victim had a gunshot wound to her stomach. The victim was immediately transported to the hospital where she was pronounced deceased.

Investigators spoke to witness A. Witness A informed investigators that they observed the shooting. Witness A provided investigators with a detailed description of the suspect vehicle and identified the driver of the vehicle.

Investigators reviewed video surveillance footage from the area. Video surveillance footage captured the shooting. Video surveillance footage showed the suspect vehicle, a gray Chrysler 300, with black rims pull up in front of 3214 Logan Avenue North. The victim walks up to the suspect vehicle. The front seat passenger who was subsequently identified as TYRONE EDWARD MADDOX, Defendant herein, gets out of the suspect vehicle and approaches the victim at the rear of the suspect vehicle. Defendant and the victim are observed standing behind the suspect vehicle. The victim is then seen falling to the ground. Defendant then runs back to the suspect vehicle and gets in the front passenger seat. The suspect vehicle then leaves the scene.

Investigators were able to identify the driver of the suspect vehicle as witness D.L. Investigators spoke to D.L. D.L. informed investigators that he owned the gray Chrysler 300 and was present during the murder. D.L. identified Defendant as the shooter. D.L. told investigators he drove Defendant to the scene and away from the scene after the shooting. D.L. informed investigators that after Defendant shot the victim, Defendant got into D.L.'s vehicle and demanded D.L. drive him away from the scene. Defendant told D.L. "I am a fucking killer in the streets!" Defendant had a handgun in his hand. D.L. asked Defendant why he shot the victim. Defendant responded, "That's none of your fucking business." Defendant then had D.L. drop him off in another area of Minneapolis.

Officers located Defendant downtown Minneapolis in the area of 9th and Nicollet Mall. Officers approached Defendant and attempted to place Defendant under arrest. Defendant ran from officers and was subsequently apprehended. While Defendant was fleeing from officers, officers observed Defendant with a handgun in his hand and subsequently discard the handgun under a vehicle. Officers searched the area and recovered a loaded .380 Kahr CW black and silver semi-automatic handgun in the area of Defendant's arrest. Defendant made several spontaneous utterances while under arrest. Defendant stated several times, "Just shoot me bro. It's over for me. Kill me now."

In a post-Miranda statement, Defendant admitted to knowing the victim and D.L. Defendant initially denied shooting the victim and claimed another unknown male shot the victim. Defendant was confronted with the video surveillance footage and statements by D.L. Defendant then admitted to shooting the victim with the firearm he discarded when he was attempting to flee from officers. Defendant admitted to selling crack and giving the victim some crack. Defendant admitted there was animosity between him and the victim because a month prior the victim had stolen around four hundred dollars from him. Defendant claimed he was under the influence of alcohol and drunk and he did not intentionally shoot the victim.

The Minneapolis Crime Lab compared the .380 DCC recovered at the scene and the .380 Kahr CW handgun discarded by Defendant while attempting to flee from officers. Forensic analysis confirmed a match. Ballistic testing concluded the spent .380 DCC recovered at the scene was fired from Defendant's recovered .380 handgun.

Defendant was previously convicted of a crime of violence and is prohibited from possessing a firearm.

On May 15, 2003, Defendant was convicted of Assault in the Second Degree (27-CR-03-025963).

On March 26, 2014, Defendant was convicted of Prohibited Person in Possession of a Firearm (27-CR-13-41383).

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

To the Sheriff of the above-named county; or other person authorized to execute this warrant: I order, in the name of the State of Minnesota, that the Defendant be apprehended and arrested without delay and brought promptly before the court (if in session), and if not, before a Judge or Judicial Officer of such court without unnecessary delay, and in any event not later than 36 hours after the arrest or as soon as such Judge or Judicial Officer is available to be dealt with according to law.
