The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

**Charge: Dangerous Weapon-Possess-in Courthouse** 

Minnesota Statute: 609.66.1g(a)(1), with reference to: 609.66.1g(a)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 10/15/2020

Charge Description: That on or about October 15, 2020, at the Hennepin County Government Center located at 300 South Sixth Street, City of Minneapolis in Hennepin County, Minnesota, THOMAS WILDER MOSELEY possessed a dangerous weapon, ammunition or explosive within a courthouse complex without consent of the Hennepin County Sheriff.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 15, 2020, officers assigned to the Court Security Division at the Hennepin County Government Center, 300 South Sixth Street, City of Minneapolis in Hennepin County, Minnesota, were informed that a group of individuals were protesting on the Public Service Level of the Government Center. Officers were informed that one of the individuals, a known adult male identified as THOMAS WILDER MOSELEY, Defendant herein, was wanted on a Minneapolis Police Department probable cause pick-up for damage to property and riot. Further, officers were informed that Defendant is known to possess and carry firearms.

Officers approached Defendant and asked for his identification. Defendant stated, "I don't need to give it to you" and began to walk through officers. As Defendant began to walk, officers observed Defendant reach for his waist. Because Defendant is known to carry a firearm, officers grabbed Defendant's hands and pulled them away from his waist area.

Defendant began to resist and attempted to pull away from officers on several occasions. Officers were able to restrain defendant and place him in handcuffs.

While conducting a search of Defendant's person, officers recovered a loaded firearm from Defendant's waistline. Officers also recovered several knives from Defendant's person.

At this time, Defendant is in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
