The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 03/15/2021

Control #(ICR#): 21054008

Charge Description: That on or about 3/15/2021, in Minneapolis, Hennepin County, Minnesota, MUBARAK OSMAN MUSSE, caused the death of Victim, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

## STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the Minneapolis Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 15, 2021 at approximately 3:17 p.m., Minneapolis Police responded to a shooting outside 912 24th Street East in the City of Minneapolis, Hennepin County, Minnesota. That address is the Village Market building, a small shopping mall. Officers responded to the area and observed Victim, a known adult male, laying on the ground unresponsive with multiple discharged firearms cartridge casings near him. Emergency medical personnel determined Victim was deceased. Officers located 15 9mm discharged cartridge casings at the scene.

Officers obtained surveillance footage from both inside and outside the address. Video shows Victim and the suspect get into an argument inside the building. The suspect can be seen leaving the mall and then coming back inside where he appears to speak to Victim. The men go outside where a brief physical fight occurs before the suspect produces a handgun and shoots the victim several times. The suspect continues to shoot Victim while Victim is on the ground as the suspect is walking away. At one point, the suspect is seen stopping, walking back toward Victim and firing again.

At approximately 4:56 p.m., MUBARAK OSMAN MUSSE, DOB 5/3/1993, Defendant, contacted police indicating he was involved in the shooting and wanted to turn himself in. Defendant told police he was in a vehicle and had the gun used in the shooting with him. Officers located Defendant and placed him under arrest. A black Glock 9mm semi-automatic handgun was observed in the glove compartment of the vehicle he was seated in. The gun was later recovered by the Crime Lab.

In a Mirandized interview, Defendant said he and Victim got into an argument about waiting in line at a tea vendor inside the incident address. He admitted to shooting Victim and identified himself in a still photograph of the shooter taken from surveillance footage of the incident. He stated the handgun recovered from the vehicle he was found in was the gun he used to shoot victim.

Defendant is in custody.
