**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sexual Cond-1st Degree-Penetration - Injury - Use Force/Coerce**

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 02/25/2018

Control #(ICR#): 18059989

Charge Description: That on or about February 25, 2018, in Hennepin County, Minnesota, Jory Daniel Wiebrand engaged in sexual penetration with Victim, and caused personal injury to her using force or coercion to accomplish sexual penetration.

**COUNT II**

**Charge: Criminal Sex Conduct-2nd Degree-Personal Injury-Force/Coerce**

Minnesota Statute: 609.343.1(e)(i), with reference to: 609.101.2, 609.343.2(b), 609.343.2(a), 609.3455.10, 609.3455.6

Maximum Sentence: 25 YEARS AND/OR \$10,500-\$35,000

Offense Level: Felony

Offense Date (on or about): 02/25/2018

Charge Description: That on or about February 25, 2018, in Hennepin County, Minnesota, Jory Daniel Wiebrand engaged in sexual contact with Victim, and caused personal injury to her/him using force or coercion to accomplish sexual contact.

Minimum Sentence: 90 MOS

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On February 25, 2018, Minneapolis Police officers were dispatched to a residence located on the 800 block of 20th Avenue NE in Minneapolis, Hennepin County, Minnesota on the report of a sexual assault. Officers spoke with a known adult female, Victim herein, who lives at this residence.

Victim told officers that she had walked to a nearby convenience store and returned home early one morning. Once in her yard, she was attacked from behind by an unknown assailant. This assailant was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein by DNA evidence.

Victim stated that Defendant put his hand over her mouth and face and tried to smother her. Defendant threw Victim to the ground and she fought back against him as he put his hands around her neck strangling her. Defendant pulled down Victim's pants and underwear and shoved his finger inside Victim's vagina and rectum. Defendant then put his hands under Victim's shirt and jacket and ripped her bra. Defendant grabbed Victim's breasts and pulled down his pants exposing his genitals. Victim stated that she fought back against Defendant and was able to get free. She ran inside her home, pushed her fridge over in front of the door, and called 911. Victim stated that her eyes, face, and genitals were burning from what she believed was pepper spray on Defendant's hands. Officers noticed that her eyes were red, and officers could smell the odor of mace.

Victim was taken to the hospital for a sexual assault examination. Victim had multiple areas of redness to her neck consistent with the described strangulation. She also suffered multiple abrasions and contusions to her arms, back, stomach, and legs as a result of this assault.

The swabbing taken from Victim's vagina was tested against a known DNA sample belonging to Defendant. The Y-chromosomal profile present in the swabbing matched Defendant's Y-chromosomal DNA profile.

Defendant was identified through DNA evidence in a string of sexual assaults, assaults, and burglaries in this same Minneapolis neighborhood occurring between 2015 and 2020. These crimes bear a marked similarity in pattern of attack. These offenses occurred on March 23, 2015, February 25, 2018, August 4, 2018, February 8, 2019, June 2, 2019, July 18, 2019, July 21, 2019, August 7, 2019, September 12, 2019, January 3, 2020, February 18, 2020, and March 1, 2020.

Defendant is presently in custody on separate charges. A warrant is request so that additional bail may be set on this case.
