The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Cond-1st Degree-Penetration - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 03/23/2015

Control #(ICR#): 15099682

Charge Description: That on or about March 23, 2015, in Hennepin County, Minnesota, JORY DANIEL WIEBRAND engaged in sexual penetration with Victim, and caused personal injury to her using force or coercion to accomplish sexual penetration.

Minimum Sentence: 144 MOS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 23, 2015, Minneapolis Police officers were dispatched to the 1300 block of 7th Street S.E. in Minneapolis, Hennepin County, Minnesota, on the report of a rape. Officers responded and spoke with a known adult female, Victim herein. Victim told officers that she had just been raped by an unknown white male in a parking lot as she attempted to scrape snow off her vehicle. This male was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein, through DNA evidence.

Victim told officers that she walked to a parking lot to retrieve her vehicle in order to pick up a friend from the bus station. Victim was scraping the snow off the vehicle when Defendant approached her from behind and sprayed her in the face with pepper spray. Defendant tackled Victim to the ground shoving her face into the pavement and snow. Defendant attempted to remove Victim's jacket but was unsuccessful. Defendant held the Victim's face to the ground and used his body weight to prevent her from moving. He pulled down her pants and ripped off her underwear. Defendant then thrust his fingers into Victim's vagina and anus as she struggled to get free. Defendant removed his finger from her vagina, repositioned himself and shoved his penis into her vagina. Victim continued to struggle against Defendant as he contorted her body on to her side and licked her vagina. Victim felt Defendant lose his balance and she was able to wiggle free. Victim ran from the scene, jumped a fence, and ran to a nearby home. The occupants of the home let Victim in, helped her wash the pepper spray from her face, and called 911. When Victim recounted the assault, she was crying and shaking. Officers also noticed that she was bleeding from her nose.

Victim was transported to the hospital for medical treatment and a sexual assault examination. Upon exam, injuries were noted to Victim's person, including abrasions to her hands, knees, and hip. Swabbings from the examination were submitted to the BCA for testing and indicated the presence of male DNA. This Y-chromosomal DNA profile matched Defendant's known DNA profile.

Victim's clothing was also collected as evidence. Forensic scientists noted the presence of semen on her pants. DNA testing was performed on the semen and the DNA was found to match Defendant.

DNA testing was also performed on the Victim's jacket. The jacket contained a mixture of Victim's DNA and two or more additional individuals. Defendant could not be excluded as a contributor, but 99.7% of the population can be excluded.

Defendant was recently charged in three separate attacks occurring between 2015 and 2019 with marked similarities to this crime. Additionally, Defendant has been linked to at least nine sexual assaults, assaults, and burglaries occurring between 2013 and 2020 in this same Minneapolis neighborhood and Anoka County. Additional charges are forthcoming.

Defendant is presently in custody on separate charges. A warrant is requested so that additional bail can be set on this case.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
