**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sexual Cond-1st Degree-Penetration - Injury - Use Force/Coerce**

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 08/04/2018

Control #(ICR#): 18260634

Charge Description: That on or about August 4, 2018, in Hennepin County, Minnesota, JORY DANIEL WIEBRAND engaged in sexual penetration with Victim, and caused personal injury to her using force or coercion to accomplish sexual penetration.

Minimum Sentence: 144 MOS

**COUNT II**

**Charge: Criminal Sex Conduct-2nd Degree-Personal Injury-Force/Coerce**

Minnesota Statute: 609.343.1(e)(i), with reference to: 609.101.2, 609.343.2(b), 609.343.2(a), 609.3455.10

Maximum Sentence: 25 YEARS AND/OR \$10,500-\$35,000

Offense Level: Felony

Offense Date (on or about): 08/04/2018

Charge Description: That on or about August 4, 2018, in Hennepin County, Minnesota, JORY DANIEL WIEBRAND engaged in sexual contact with Victim, and caused personal injury to her using force or coercion to accomplish sexual contact.

Minimum Sentence: 90 MOS

## COUNT III

### **Charge: Burglary-1st Deg-Assault Person In Build/On Property**

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Charge Description: That on or about August 4, 2018, in Hennepin County, Minnesota, JORY DANIEL WIEBRAND, either directly or as an accomplice, entered a building, without consent and with intent to commit a crime or committed a crime, while in the building and assaulted Victim, a person within the building or on the building's appurtenant property.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 4, 2018, Minneapolis Police officers were dispatched an address on the 800 block of 6th Street S.E. in Minneapolis, Hennepin County, Minnesota, on the report of a rape and robbery. Officers responded and spoke with a known adult female, Victim herein. Victim told officers that she had just been raped by an unknown white male in her residence. This male was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein, through DNA evidence.

Victim stated that she returned home from spending time with friends at about 2:30 a.m. She stated that she sat on her back patio to smoke a cigarette. On her way into her home, Defendant blitz attacked Victim from behind. Defendant put one arm around Victim's neck and covered her mouth with his other hand. He pushed Victim into her home and told her to be quiet. Defendant then moved his hand under Victim's shirt and fondled her bare breast as he continued to choke her with his other. Defendant reached into the Victim's leggings and inserted his fingers into her vagina. Defendant shoved Victim onto the couch and pulled down his black sweatpants exposing his penis. Victim struggled against Defendant and, in response, he sprayed pepper spray into her face burning her eyes. Defendant then grabbed Victim's purse that was around her shoulder and fled the apartment. Victim ran to wake up her roommate who called 911 while she flushed her eyes with water. When officers were speaking with Victim, they noticed that she was tearful, having trouble breathing, and spoke with a raspy voice consistent with strangulation.

Victim was transported to the hospital for a sexual assault examination. A swabbing was taken from her left breast that had been touched by Defendant. This swabbing was submitted to the BCA for DNA testing and compared against Defendant's known DNA sample. The swabbing contained a mixture of DNA, Defendant could not be excluded as being a contributor to this mixture, but 99.9999999997% of the population is excluded.

Defendant was recently charged in three separate attacks occurring between 2015 and 2019 with marked similarities to this crime. Additionally, Defendant has been linked to at least nine sexual assaults, assaults, and burglaries occurring between 2013 and 2020 in this same Minneapolis neighborhood and Anoka County. Additional charges are forthcoming.

Defendant is presently in custody on separate charges. A warrant is requested so that additional bail can be set on this case.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
