COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Cond-1st Degree-Penetration/Contact - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 08/07/2019

Control #(ICR#): 19234458

Charge Description: That on or about August 7, 2019, in Minneapolis, Hennepin County, Minnesota, JORY DANIEL WIEBRAND engaged in sexual penetration and caused personal injury to Victim while using force or coercion to accomplish the act.

COUNT II

Charge: Burglary-1st Deg-Assault Person In Build/On Property

Minnesota Statute: 609.582.1(c), with reference to: 609.582.1

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 08/07/2019

Charge Description: That on or about August 7, 2019, in Minneapolis, Hennepin County, Minnesota, JORY DANIEL WIEBRAND, either directly or as an accomplice, entered a building, without consent and with intent to commit a crime or committed a crime, while in the building and assaulted Victim, a person within the building.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 7, 2019, Minneapolis Police officers were dispatched to a residence located on the 700 block of 4th Street S.E. in Minneapolis, Hennepin County, Minnesota, on the report of a sexual assault. Officers spoke with a known adult female, Victim herein, who lives at this residence.

Victim told officers that she had returned home from work early that morning and took a shower around 4:00 a.m. After the shower, she walked into her bedroom to get dressed and was attacked by an unknown intruder in her home. This intruder was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein. Victim stated that Defendant put one hand over her nose and mouth preventing her from breathing and one arm across her chest. Defendant threw Victim on the bed with her face down into a pillow. Defendant pushed Victim's face into the pillow as he climbed on top of her. Defendant thrust his fingers into Victim's vagina. Victim recounted that the only thing Defendant said during the assault was, "I'm your worst nightmare." Victim fought against Defendant and was able to flip her body over. She kicked Defendant in the stomach and was able to see his face. She described her attacker as a white male in his 30s with a shortly trimmed reddish brown beard with acne scars on his face. After Victim kicked Defendant, he sprayed her in the face with pepper spray. Victim continued to fight, and Defendant fled her apartment.

Victim ran to her upstairs neighbor's apartment naked and screaming. Victim tried to wash the pepper spray out of her eyes as her neighbors helped her, covered her, and called the police. Victim was taken to the hospital for a sexual assault examination. Victim suffered multiple abrasions and contusions to her chest, back, knees, arms, eyes, and cheek as a result of this assault.

Police examined Victim's residence and noticed that several plastic patio chairs were stacked under an unlatched window in Victim's apartment. These chairs had not been in this location previously.

The swabbings taken from Victim's mons pubis and perineal areas were tested against a known DNA sample belonging to Defendant. Defendant could not be excluded as a contributor to the DNA mixture on Victim's swabs; however, 99.9992% and 99.99998% of the population respectively are excluded.

Defendant has been linked to nine other sexual assaults, assaults, and burglaries occurring between 2013 and 2020 in this same Minneapolis neighborhood and Anoka County, Minnesota. Additional charges are forthcoming.

Defendant is presently in custody on a related crime. A warrant is requested so bail may be set on this offense as well.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
