The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 09/09/2021

Control #(ICR#): 21206011

Charge Description: That on or about 9/9/2021, within the city of Minneapolis in Hennepin County, Minnesota, Tyreese Joseph Giles, caused the death of Victim 1, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On September 9, 2021 at approximately 8:00 p.m. Minneapolis police responded to 2125 Glenwood Avenue within the city of Minneapolis, Hennepin County, Minnesota also known as the "Pennwood Market". Officers received report of a shooting that just occurred and that 2 victims had been driven to the hospital before first responders could arrive. Both victims were taken to Hennepin County Medical Center (HCMC) and Victim 1 succumbed to gunshot injuries hours later.

Officers observed numerous discharged cartridge casings (DCCs) at the shooting scene, located video surveillance from the Pennwood Market and also collected Milestone video from the intersection of Glenwood and Penn Avenue.

Officers observed through the video, Victim 1 standing outside of a vehicle at the Pennwood Market talking with 2 other males. The three males are then seen running away and Victim 1 holding his chest from an apparent gunshot. The suspect shooter can be seen shooting at Victim 1. Victim 1 tries to run into the Pennwood Market, then back to the vehicle, before collapsing. The suspect shooter can then be seen advancing towards Victim 1 and continuing to shoot. After the suspect runs away from the market, Witness 1 fires a gun back at the suspect shooter before loading Victim 1 into a vehicle to drive to the hospital.

The second gunshot wound victim to arrive at the hospital was identified as TYREESE JOSEPH GILES (DOB: 7/03/2000), herein after "Defendant". Defendant had multiple gunshot wounds. In review of video surveillance, Defendant is identified as the suspect shooter. Defendant arrived at the hospital approximately 9 minutes after the shooting wearing matching clothing as is seen on the surveillance video including detailed markings on his shoes and clothing.

Defendant is in custody pending charges from this incident.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
