**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence**

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence:

Charge Description: That on or about 9/17/2020, in Minneapolis, Hennepin County, Minnesota, Jomoy Tremayne Lee possessed ammunition or a firearm and Jomoy Tremayne Lee has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Aggravated Robbery in the First Degree on 10/11/2019, for which the sentence or court supervision expired on or after August 1, 1993.

**Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence**

**COUNT III**

**Charge: Fleeing a Peace Officer in a Motor Vehicle**

Charge Description: That on or about 9/17/2020, in Minneapolis, Hennepin County, Minnesota, Jomoy Tremayne Lee did by means of a motor vehicle, flee or attempt to flee from a peace officer acting in the lawful discharge of an official duty, who Jomoy Tremayne Lee knew or reasonably should have known was a peace officer.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On September 17, 2020, Minneapolis police officers were conducting electronic surveillance and following murder suspect JOMOY TREMAYNE LEE (D.O.B. 12/07/2002) (hereinafter "Defendant"), who was the sole occupant and driver of a dark colored Chevrolet Impala (MN license plate EVV-148) near the area of 7th Street and Lyndale Avenue North, in the city of Minneapolis, Hennepin County, Minnesota. Officers knew Defendant to be involved in a homicide that occurred in north Minneapolis, on September 14, 2020, in which the victim was a 17-year-old male. Officers also knew Defendant to carry firearms and associate with violent gang members.

On September 17, 2020, two marked police squad cars attempted to stop Defendant at the intersection of 7th Street and Lyndale Avenue North, but Defendant fled officers and began driving a random route through the North Loop area of downtown Minneapolis. During the pursuit, officers observed Defendant throwing items out of his car. First, Defendant threw out a cellphone when crossing 650 2nd Street North. The cellphone was recovered by officers shortly thereafter in the middle of the street. When Defendant reached 3rd Avenue North, he threw a gun out of the window by Parking Ramp C. An officer later located this handgun in the 300 block of 3rd Avenue North. The gun was a Taurus semi-automatic pistol, with a black frame and silver slide. The gun was loaded with a magazine and ammunition, as well as a 9 mm bullet in the chamber.

Defendant continued fleeing and entered I-394 West by driving through swing arm barricades of the HOV lane, going the wrong way, into oncoming traffic. The swing arm barricades had flashing red lights, the ground in that area said, "exit", and the sign above the ramp read "closed" at that time.

Defendant then entered northbound US Highway 169. Defendant exited the Highway at Medicine Lake Road and turned westbound. At this point, Golden Valley Police Department squad cars were behind Defendant in an effort to stop him. During the pursuit, squad cars had their sirens and lights on. Defendant continued fleeing until he reached a residence in the 2900 block of Medicine Lake Boulevard. A Golden Valley squad car hit Defendant's Impala, finally ending the pursuit in the city of Plymouth, Hennepin County, Minnesota. Officers noted the Impala had sustained body damage from the flee, the engine appeared to be smoking, and Defendant was trying to crawl out of the driver's side window. Officers tried taking Defendant into custody, but he actively resisted officers by hooking his feet into the steering wheel of the car to prevent officers from apprehending him. Officers were eventually able to detain Defendant.

Upon searching the Impala officers located a .22 caliber revolver wrapped in a blue piece of clothing on the passenger side floorboard. Officers also located 12.2 grams of suspected marijuana inside the car.

Defendant is currently on Extended Juvenile Jurisdiction probation for Aggravated Robbery in the First Degree (MNCIS no. 27-JV-19-4347). Defendant was sentenced in that matter on December 12, 2019, and, as the sentencing order in that case explained, that is a conviction for a crime of violence under Minn. Stat. Section 624.712 and Defendant is banned for life from possession a pistol or assault weapon or any other firearm.

ON OCTOBER 28, 2020, DEFENDANT WAIVED CERTIFICATION PROCEEDINGS IN FRONT OF THE HONORABLE FRANCIS J. MAGILL AND WAS THEREAFTER ORDERED TO STAND TRIAL AS AN ADULT.
