The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### COUNTI

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1

Maximum Sentence: Forty years.

Offense Level: Felony

Offense Date (on or about): 11/12/2021

Control #(ICR#): 21260911

Charge Description: That on or about November 12, 2021, in Hennepin County, Minnesota, ROBERT DAVID LLOYD HALL, caused the death of K.P. a human being, with intent to effect the death of that person or another, but without premeditation, while using or possessing a firearm.

#### **COUNT II**

Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony

Minnesota Statute: 609.19.2(1), with reference to: 609.19.2(1), 609.11.5(a)

Maximum Sentence: Forty years.

Offense Level: Felony

Offense Date (on or about): 11/12/2021

Charge Description: That on or about November 12, 2021, in Hennepin County, Minnesota, ROBERT DAVID LLOYD HALL, did without intent to effect the death of any person, cause the death of K.P., a human being, while committing or attempting to commit the felony offense of Assault in the Second Degree while using or possessing a firearm.

#### **COUNT III**

**Charge: Simple Robbery** 

Minnesota Statute: 609.24, with reference to: 609.24, 609.17.4(2)

Maximum Sentence: Five years.

Offense Level: Felony

Charge Description: That on or about November 12, 2021, in Hennepin County, Minnesota, ROBERT DAVID LLOYD HALL, attempted to take personal property, from the person or in the presence of M.R., knowing that he was not entitled to the property and used and/or threatened the imminent use of force against the M.R. to overcome her resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property.

#### **COUNT IV**

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence: Fifteen years.

Offense Level: Felony

Offense Date (on or about): 11/12/2021

Control #(ICR#): 21260911

Charge Description: That on or about November 12, 2021, in Hennepin County, Minnesota, ROBERT DAVID LLOYD HALL, possessed ammunition or a firearm and ROBERT DAVID LLOYD HALL has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Third Degree Drug Possession (27-CR-15-33977) on March 4, 2016, for which the sentence or court supervision expired on or after August 1, 1993.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about November 12, 2021, at approximately 9:49 a.m. officers with the Minneapolis Police Department were dispatched to the intersection of West Broadway Avenue and Lyndale Avenue North in Minneapolis, Hennepin County, Minnesota, on the report of a car accident involving two vehicles that escalated into a shooting. Upon arrival, officers observed the adult male victim K.P. lying unresponsive in the intersection with a gunshot wound to the chest. The victim was subsequently pronounced deceased at the scene.

Officers spoke to several witnesses at the scene. Witnesses informed officers that a gray Chevy Monte Carlo driven by ROBERT DAVID LLOYD HALL, Defendant herein, ran a red light and crashed into a black Mercury Mountaineer driven by L.B. After the crash, Defendant exited his vehicle and attempted to flee the scene on foot. The victim and two other witnesses ran after Defendant and attempted to detain Defendant until police arrived. Defendant physically resisted and shot the victim in the chest with a firearm. Defendant subsequently fled to Cub Foods. The adult female victim M.R. was driving her vehicle in the parking lot of Cub Foods when Defendant opened M.R.'s car door and forcibly attempted to steal her vehicle. Several witnesses intervened and pulled Defendant out of M.R.'s vehicle and detained Defendant until police arrived. While witnesses were detaining Defendant, a silver .22LR caliber Jennings firearm fell out of Defendant's pocket. Witnesses also removed a bullet proof vest from Defendant and a backpack containing narcotics.

Officers searched Defendant's vehicle. Inside Defendant's vehicle officers recovered .357 caliber firearm.

The entire incident was captured on video surveillance cameras in the area and confirmed witnesses account of what happened.

Routine checks revealed Defendant was previously convicted of a crime of violence and is prohibited from possessing a firearm.

On June 3, 2008, Defendant was convicted of Conspiracy to Commit First Degree Manufacturing of Meth (27-CR-04-019468). On March 4, 2016, Defendant was convicted of Third Degree Drug Possession (27-CR-15-33977). On December 17, 2020, Defendant was convicted of Fifth Degree Drug Possession (27-CR-19-30931).

In a post-Miranda statement, Defendant admitted to getting into a car accident and attempting to flee the scene because he had a warrant, guns, drugs, and a bullet proof vest in his possession. The victim and two other individuals attempted to prevent Defendant from fleeing the scene of the accident. During the physical altercation with the victim, the firearm in Defendant's pocket went off and shot the victim. Defendant also admitted to being prohibited from possessing a firearm and owning and possessing the two firearms recovered from the scene.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
