The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 08/24/2020

Control #(ICR#): 20220000

Charge Description: That on or about August 24, 2020, in Hennepin County, Minnesota, SAID SHARIF MAYE caused the death of Victim, a human being, with intent to effect the death of that person or another, but without premeditation.

**COUNT II**

**Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony**

Minnesota Statute: 609.19.2(1), with reference to: 609.19.2(1)

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 08/24/2020

Control #(ICR#): 20220000

Charge Description: That on or about August 24, 2020, in Hennepin County, Minnesota, SAID SHARIF MAYE did without intent to effect the death of any person, cause the death of Victim, a human being, while committing or attempting to commit the felony offense of criminal vehicular operation.

## STATEMENT OF PROBABLE CAUSE

AMENDED COMPLAINT: COUNTS 1 AND 2 ADDED, FORMER COUNT 1 (CRIMINAL VEHICULAR HOMICIDE) HAS BEEN REMOVED.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about August 24, 2020, at approximately 2:25 a.m., Minneapolis Police officers were dispatched to the intersection of Franklin Avenue and Lyndale Avenue, Minneapolis, Hennepin County, Minnesota, in regard to a hit and run accident. A known adult male, Victim hereafter, died as a result of injuries sustained from being struck by the fleeing suspect vehicle. Officers spoke to a known adult male, Witness 1 hereafter, who stated he was with Victim and SAID SHARIF MAYE, Defendant hereafter, at a bar earlier in the evening. Witness 1 stated that Defendant was upset with Witness 1 and Victim throughout the night, and that upon leaving the bar he observed Victim getting into his vehicle when a vehicle driven by Defendant struck Victim and pinned Victim against Victim's vehicle. Witness 1 indicated that Defendant crossed into the opposite lane to do so, and that Defendant's actions appeared intentional. Officers confirmed that Defendant had used a credit card to start a tab at the bar Witness 1 stated the three were at earlier in the evening.

The suspect vehicle, which was registered to Defendant, was later located and had damage consistent with the version of events described by Witness 1. Officers also received an anonymous tip that the suspect vehicle had been driven by Defendant into Victim, causing Victim's death.

Due to the severity of the offense and information that Defendant is attempting to leave the country, a warrant is requested.

The State hereby notifies Defendant of its intent to add a charge of Murder in the Second Degree, pursuant to Minn. Stat. Sec. 609.19, subd. 1(1), if this case proceeds to trial.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
