The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - Without Intent - While Committing a Felony

Minnesota Statute: 609.19.2(1), with reference to: 609.19.2(1)

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 03/06/2022

Control #(ICR#): 22048007

Charge Description: That on or about 3/6/2022, in Hennepin County, Minnesota, Emmanuel Troy Davis, did without intent to effect the death of any person, cause the death of J.L.D., a human being, while committing or attempting to commit the felony offense of Aggravated Robbery in the First Degree.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 6th, 2022, officers received a call from Witness, who indicated that she had received a disturbing video of an assault on her family member. In it, Victim was being kicked multiple times in the head and was not moving. The video of the assault appeared to have been posted from Victim's phone to Facebook. Witness provided officers with the video, which is shot from a third-person point of view. The video shows Victim, unconscious, while a male stands over Victim. The male removes a cellphone from Victim's coat pocket area and grabs Victim by the throat saying, "where yo pipe at?" The male then turns and leaves and a female voice says, "damn." The video closes on Victim's face as he lays unconscious on the ground. The video then appears to skip back to before the robbery. The male is shown stomping and kicking Victim's head and neck. Victim is already unconscious on the ground during the assault. The male says "b*tch" as he stomps and kicks Victim's head. The female videographer is laughing in the background.

Officers called local hospitals and located an assault victim, who turned out to be Victim. He was unresponsive and had suffered severe head trauma. He later died due to his injuries.

Officers learned that Victim had been located unconscious in an apartment building at 13xx Nicollet Avenue, Minneapolis, Hennepin County, Minnesota and was transported to the hospital.

Officers reviewed video from the apartment building on March 6th and observed Victim entering the building with a female at 21:15 hours. Officers and an ambulance arrive at 22:08 hours, and Victim is transported out on a stretcher.

Officers spoke with Witness, who indicated that the video of the assault had been posted on Victim's Facebook page with a particular tag. Officers traced that Facebook page back to Defendant EMMANUEL TROY DAVIS. Multiple people who know Defendant identified him as the person kicking and stomping on Victim in the video.

In a post-Miranda interview, Defendant admitted to hiring his girlfriend, a known juvenile, to lure Victim to the apartment. He also stated that he planned to "stomp on his a**, f*** his a** up for a little bit." He also admitted to stealing Victim's phone and to sending videos and messages to people after the assault to "f***" with them.

Defendant is on EJJ probation for two aggravated robberies and is in custody for probation violations for those offenses. The State is requesting a rush warrant due to the nature of the offense and Defendant's custody status.

The State intends to seek an upward departure due to the particular cruelty shown to Victim and his family.
